Sir,

I, RABI MUHURI, son of Late Hriday Muhuri, permanent resident of 2 No. Jyotinagar, Ward No. 04 under S.M.C., P.O. Silliguri Bazar, P.S. Silliguri, Dist. Darjeeling, would like to inform you that as follows:-

1. That PUSHPA MUHURI, wife of Late Hriday Muhuri, (now deceased) was/is my mother who died on 17.11.2008. She was a recorded PATTA holder of vacant land measuring 4 Kathas 1 Chhataks situated 2 No. Jyotinagar, Ward No. 04 under S.M.C., P.O. Silliguri Bazar, P.S. Silliguri, Dist. Darjeeling. After her death I along with my brothers namely ARUN MUHURI and BIDHAN MUHURI, both are sons of Late Hriday Muhuri became the joint owners of the aforesaid land by virtue of inheritance. Later on 12.07.2018 I, Arun Muhuri and Bidhan Muhuri mutated the aforesaid land in our names from the concerned authority and later I and my younger brother namely ARUN MUHURI constructed two separate tin shed residential houses over the aforesaid land. Currently I have been residing with my wife namely ANITA MUHURI in one of the tin shed residential house and my aforesaid younger brother have been residing with his wife namely REBA MUHURI in the other tin shed residential house.
2. That since the year 2018 my said younger brother namely ARUN MUHURI, his wife namely REBA MUHURI and my wife namely ANITA MUHURI have been trying to occupy my acquired part of the aforesaid mutated land forcefully and illegally by evicting me from my own tin shed residential house for their malafide gain.
3. That on 19.09.2024 at about 4.00 P.M. said ARUN MUHURI, REBA MUHURI entered my house carrying knife and bamboo respectively and in the presence of my wife started to threatened me that if I do not hand them over our mother's original PATTA paper and our original MUTATION paper of the aforesaid land then they will kill me by piecing my throat. When I refused accept their demand all of the above persons beat me mercilessly with bamboo, fists kicks and blows on my persons and as a result I fell on the floor. Sid ARUN MUHURI also tried to attack with the knife but I finally agreed to their demand in the fear of losing my life and handed over our mother's original PATTA paper and our original MUTATION paper to them. More over my said younger brother and his wife snatched all other original PATTA documents of our deceased mother. While my younger brother and his wife leaving the spot they again threatened me that if I do not give my share of the aforesaid landed property to them within few days then they will kill me. I therefore, request you to kindly take appropriate legal action against ARUN MUHURI, REBA MUHURI and REBA ANITA MUHURI and take necessary steps to recover all the original documents. I shall be highly obliged to you forever.
