Respected Sir,


I Sanjib Sarkar Son of Late Girendra Nath Sarkar, resident of Haiderpara Bazar, Ward NO-39. Police Station Bhaktinagar, Dist-Jalpaiguri, in the state of West Bengal do hereby writes you for your kind perusal and necessary action:

1. That I am a resident of the above-mentioned address and I am living at that address for 1.5 years approx.
2. That a person introduced himself as a sales executive of Goyal Construction Private Limited having its office at Panjabi Para, Sevoke Road, Siliguri 734001.
3. That he offered me an offer to purchase a flat in the above-mentioned company.
4. That on many times he contacted me and offered to purchase such a flat in his company, and after his repeated request I was compelled to purchase a flat.
5. That on the very same day on 24/9/2021, I gave him 3 Lac Rupees as a booking amount and he provides me a receipt which was issued in his name when I object to this issue he told me that this was mistakenly issued in his name and this will be corrected.
6. That again on 28/2/2022 I paid him 2 Lac Rupees as another installment through the mode of cheque and said was mentioned in my bank account statement. That after it when I tried to establish contact with him then him always making excuses from one pretext to another. In the meanwhile, when I tried to establish contact with Goyal Construction Private Limited with this issue they fail to do so. Now I am feeling that the above-named person cheated and betrayed me.

7. A person named Saraswati Bhowmick, who worked at a place with my daughter, first introduced me to Partha Ghosh, she was Partha Ghosh's girlfriend. Saraswati Bhowmick used to tell me in advance that Partha Ghosh would find me a good flat, not to worry at all. I gave the first advance of Rupees 3 Lakh to Partha Ghosh with my own hand in front of her. My daughter thinks Saraswati Bhowmick is equally responsible for this fraud.

8. That it is also prominent to mention here that Partho Ghosh breached my trust and cheated me and Partho Ghosh also deceive my money for his gain and ill motive.

Under the above facts and circumstances, I request that you kindly take cognizance of the matter and do the needful in the interest of justice.
