I, Smt. Alpana Barman (Gope), Staff Nurse Gr. II of North Bengal Medical College & wife of Mr. Sushanta Gope and a resident of Quarter No. C-3, NBMCH Campus, North Bengal Medical College would like lodge complain for the following event:-

On 15.10.2024 at the eve of Durga Puja Bijoya celebration, I had shared some of my personal pictures in my facebook profile around 6 p.m to 7 p.m. After that, an office employee named Mr Utpal Sarkar, Head Clerk of the office of the Principal, North Bengal Medical College commented some indecent words to my pictures stating "Tui Kobe thambi re kutta,, bachcha" on the same day. The screenshot of the same is attached herewith. After seeing such vulgar comments , I asked Mr. Utpal Sarkar in the same facebook trailing comment what he wanted to mean and again after few hours, I have noticed that he has deleted his comment. It may please be noted that both Mr. Utpal Sarkar and I work in the same campus and whenever he passes beside me he seems to look at me in an indecent manner and every time he gives some kind of eye signals which we ladies consider as bad gestures. I would like to inform you that I am not directly connected with Mr. Utpal Sarkar and I do not find any sort of justification for this kind of behavior. He is continuously harassing me mentally for more than 2 (two) years and now, this time it is completely unbearable. I am being socially defamed by Mr. Utpal Sarkar and I am very much frustrated as my family members and my relatives are also concerned about this type of defamatory words. Even, I am not feeling secure in my workplace because I have come to know that he is very influential person politically. I am sharing the contact numbers of said Mr.-Utpal Sarkar which are 7001297459 / 8768277954 / 9474903717.

So, I am demanding proper justice and I am also demanding utmost punishment of Mr. Utpal Sarkar so that I could perform my official duty without any fear.

Kindly set the law of land in motion and take necessary steps against Mr. Utpal Sarkar.
