In producing herewith the 04(Four) accused persons namely 1. Md. Chand (M/27 years) S/O- Lt. Md. Nashir of Swaminagar Colony, Vivekananda Road, Ward No-07 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling. 2. Md. Ramjan Hossain @ Jabbar (M/28 years) S/O-Md. Anwar Hossain of Khalpara, Vivekananda Road, Ward No. 07 of SMC, PO & PS-Siliguri, Dist-Darjeeling, at present Diesel Colony, Ward No. 01 of SMC, PS-Pradharninagar, Dist-Darjeeling 3. Rajesh Mandal (M/33 years) S/O Lt. Mangal Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.O+P.S- Siliguri, Dist.- Darjeeling and 4. Gulam Mustafa @ Kalu (M/44 Years) S/O Lt. Md. Lal of Darbhanganatola, Chappal Patty, Ward No. 06 of SMC, P.O+P.S- Siliguri, Dist.- Darjeeling (Not verified) under arrest along with the following seized articles:-

1. One iron made Chopper having iron made butt measuring approx. 32 cm in length which is found on the back side of accused person named Md. Chand.
2. One iron made rod measuring approx. 85 cm in length which is found on the right hand of the accused person namely Md. Ramjan Hossain @ Jabbar.
3. One steel made pipe measuring approx. 82 cm in length which is found on the right hand of the accused person namely Rajesh Mandal.
4. One iron made of sword having iron made butt measuring approx. 75 cm in length which is found on the right hand of the accused person namely Gulam Mustafa @ Kalu.

1. SI Chiranjit Saha, s/o-Madhab Saha of Khalpara TOP-II under Siliguri Police Station/SPC would like to lodge this written complaint against the above noted persons and 06(six) other accused persons namely 1. Anish Gupta of Bucchar patty under Siliguri Police Station, 2. Rajkumar Mandal of Swaminagar Colony under Siliguri Police Station, 3. Md. Chattu @ Langra of Tulshinagar under Matigara Police Station, 4. Md. Zahid of Chathut under Phansidewa Police Station 5. Azhar of Khalpara under Siliguri Police Station and 6. Basirul Hoque @ Kalu of Khalpara area under Siliguri Police Station to the effect that today i.e. on 19.10.2024 at about 00.45 hours received a secret source information that a group of 09/10 persons had assembled at in a vacant place beside Power House near Jhankar More under Siliguri Police Station /SPC with deadly weapons with a view to commit some heinous crime. Accordingly, the information was diarized vide Khalpara TOP-II GDE No. 496 Dated. 19.10.2024. Accordingly without wasting any time, I informed the matter to O/C Khalpara TOP-II under Siliguri PS and IC Siliguri PS over telephone and as per telephonic instruction, myself along with SI Newton Biswas, ASI Inzamamul Hoque, C/ 1565 Santu Barman, C/ 717 HIRAK ROY, C/ 1479 Dilip Barman, All of Khalpara TOP under Siliguri Police Station headed towards a vacant place beside Power House near Jhankar More under Siliguri Police Station/ SPC to verify the veracity of the information and to work upon it. This refers Khalpara TOP-II GDE No. 497 Dated. 19.10.2024. I also Informed Night Van Officer namely SI Bishnu Pada Halder of Khalpara TOP-II under Siliguri Police Station to come at a vacant place beside Power House near Jhankar More under Siliguri Police Station/ SPC to assist us. On way to the P.O I called two disinterested independent witness namely 1. Md. Islam (46 years) S/O Lt. Md. Dayud of Santoshinagar, near Ram Janki Mandir, Ward No. 05 of SMC, PO & P.S- Siliguri, Dist.- Darjeeling & 2. Bapi Roy (30 years) S/O Bikash Roy of Patiramjote, PO & PS- Matigara, Dist.- Darjeeling whom we disclosed the matter regarding our information and identity and asked them to accompany us if any search and seizure is necessary for the purpose. We reached near the spot as directed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement and found a group of 10 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04(Four) above referred accused persons.

On interrogation the 04(Four) persons disclosed their identity as noted above and confessed that they along with 06 other persons namely 1. Anish Gupta of Bucchar patty under Siliguri Police Station, 2. Rajkumar Mandal of Swaminagar Colony under Siliguri Police Station, 3. Md. Chattu @ Langra of Tulshinagar under Matigara Police Station, 4. Md. Zahid of Chathut under Phansidewa Police Station 5. Azhar of Khalpara under Siliguri Police Station and 6. Basirul Hoque @ Kalu of Khalpara area under Siliguri Police Station had assembled there with a view to commit dacoity after making full preparation in a Night Super Bus at Jhankar More under Siliguri Police Station. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were recovered from their possession-

1. One iron made Chopper having iron made butt measuring approx. 32 cm in length which is found on the back side of accused person named Md. Chand.
2. One iron made rod measuring approx. 85 cm in length which is found on the right hand of the accused person namely Md. Ramjan Hossain @ Jabbar.
3. One steel made pipe measuring approx. 82 cm in length which is found on the right hand of the accused person namely Rajesh Mandal.
4. One iron made of sword having iron made butt measuring approx. 75 cm in length which is found on the right hand of the accused person namely Gulam Mustafa @ Kalu.

All the articles were seized in between 01.25 hours to 01.45 hours. issuing a proper seizure list duly signed by the witnesses and the accused persons. The whole process of seizure is video-graphed. Then, I arrested the above noted apprehended accused persons after issuing memo of arrest, as they had assembled for committing dacoity in a Night Super Bus at Jhankar More.

Under the above circumstances, I pray before you that a specific case may kindly be initiated against the 04 (four) arrested accused persons namely 1. Md. Chand (M/27 years) S/O-Lt. Md. Nashir of Swaminagar Colony, Vivekananda Road, Ward No-07 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling, 2. Md. Ramjan Hossain @ Jabbar (M/28 years) S/O-Md. Anwar Hossain of Khalpara, Vivekananda Road, Ward No. 07 of SMC, PO & PS-Siliguri, Dist-Darjeeling, at present Disel Colony, Ward No. 01 of SMC, PS-Pradhannagar, Vivekananda Road, Ward No. 07 of SMC, P.O+P.S- Siliguri, Dist.- Darjeeling and 4. Gulam Mustafa @ Kalu (M/44 Years) S/O Lt. Md. Lal of Darbhangatola, Chappal Patty, Ward No. 06 of SMC, P.O+P.S- Siliguri, Dist.- Darjeeling (Not verified) and 06 (six) other persons namely 1. Anish Gupta of Bucchar patty under Siliguri Police Station, 2. Rajkumar Mandal of Swaminagar Colony under Siliguri Police Station, 3. Md. Chattu @ Langra of Tulshinagar under Matigara Police Station, 4. Md. Zahid of Chathut under Phansidewa Police Station 5. Azhar of Khalpara under Siliguri Police Station and 6. Basirul Hoque @ Kalu for assembling with deadly weapons with a view to committing dacoity.
