Respected Sir,

I Kamalawati Gupta, Wife of Chotelal Gupta, Resident of Vidyapati Sarani, Bankim Nagar, Iskcon Road, Ward No. 41, S.M.C., P.S. Bhaktinagar, District: Jalpaiguri beg to state as follows:

1. That my son namely Sunny Gupta got married to one Nandni Gupta on 03/06/2023 whereon after the marriage she had been staying with us in our above mentioned address.
2. Since day one of the marriage my daughter in law was not willing to stay with us as a joint family and use to always induce my son to go and live with her at her maternal house in Bihar where she would be free from all kinds of responsibilities and duties. My son never agreed to that as he is my only son and he did not want to desert his aged parents at an old age. My said daughter in law would not do any household work and would pick up quarrels with me and my husband on baseless issues and would threaten us of dire consequences where she once even stated that she would file a false case against us and would implicate my husband and myself in dowry cases and attempt to murder.
3. That we would always try to make her understand and request her to stay happily with the family and would not even pressurize her to do the household work and other chores. My said daughter in law was also in the habit of going to her maternal house every now and then without informing anyone at home and when we would inquire about her

whereabouts she would threaten to kill me and implicate my son and husband in false cases.

4. That on 18/08/2024 my daughter in law again without informing anyone went away to her maternal house and has been continuously threatening me to send my son to her or else she will kill me and would forcefully take my son along with her to her maternal house. I requested her not to do anything such and even told her to come back home as this was her home and she was the daughter in law of the house, but my daughter in law only kept on threatening me and kept on repeating that she would get my husband and me murdered if we didn't send our son to her maternal house.
5. That on 11.09.2024 when my son called his wife over phone requesting her to come back home and to live a happy conjugal life she flatly denied on his face and threatened to file numerous false cases against him and the rest of the family.
6. That after that my daughter in laws father namely Durga Prasad Gupta called my son over phone and started abusing him in filthy languages after which her two uncles namely Dhiraj Gupta and Rajesh Gupta along with my sons brother in law namely Roshan Gupta started abusing my son and threaten to get him and the entire family by either giving supari to some criminal or by getting our accident done on the road. When my son asked them to stop threatening him and to send back his legally wedded wife they in turn told that she will never come back and now they will falsely implicate us in different cases and soon will also get us killed by some supari killer.
7. That since after receiving the threatening calls by my son from his in-laws he is in deep mental trauma and fear. We have even shown him to a

psychiatrist namely Dr. Arunava Dutta where he is getting treated and my husband also had a recent eye surgery.

8. That thereafter on 12.09.2024 we informed the aforesaid matter to the Bhaktinagar I.C. and for the same a receiving was given to us. That thereafter today i.e. 20.10.2024 my sons in laws namely Durga Prasad Gupta, Dhiraj Gupta , Rajesh Gupta along with four other men came to our house in the above mentioned address entered my house forcefully and started beating my son ruthlessly whereon my son received a lot of injuries alongwith a fractured hand and several injuries on the head and other body parts. My son's father in law namely Durga Prasad Gupta even strangulated him with a rope and was on the verge of killing my son. When we tried saving our son the said persons threatened to kill my son on spot and the said persons caught hold of my dupatta and touched my private parts with the intention to disrobe me. When we raised hues and cries and cried out for help they ran away from there saying that they will soon kill my entire family.
9. That I and my entire family is in great fear and in a state of shock as the in-laws of my son are very dangerous in nature which we came to know after my son got married and even after today's incident.

Sir we are in deep fear and are scared after the threatening. We live alone and have no one to protect us. My son is already in depression and in mental trauma and has sustained a lot of injuries along with a fractured hand. He is currently under medical treatment at the Civil Hospital. I therefore request you to kindly take strict action against the aforesaid.
