Respected Sir,

With due respect I, Arbind Kumar Mahato, Son of Shri Sakal Mahato, aged about 38 years, resident of Santoshi Nagar, Ward No. 05, Siliguri, P.O- Siliguri Bazar, P.S- Siliguri, District- Darjeeling, West Bengal, Pin- 734005 would like to inform you that today at about 09:00 am in the morning, my younger brother namely Rajiv Kumar Mahato, Son of Shri Sakal Mahato started to abuse my son namely Anant Mahato (07 years), Prashant Mahato (12 years) and my daughter namely Muskan Mahato (10 years). That all my sons and daughter are school going children and every day when they go to their school or tuition, my younger brother namely Rajiv Kumar Mahato and his wife namely Paano Devi (nickname), uses to abuse them in filthy language.

That today when my children Anant and Muskan was on the way to meet me at my shop situated at Santoshi Nagar near Santoshi Mandir, Siliguri the said Rajiv Kumar Mahato started to abuse my children in filthy language and also slapped my daughter on her face. That both my children started to crying and narrated the whole incident to me. That on knowing these incidents, I went to his place and asked him why did you slapped my daughter and why do you use such abusive languages to my children?, they will learn what they will hear from their guardian or senior citizens. That on asking and requesting him not to use such abusive words to my children, the said Rajiv Kumar Mahato started to hit me. He started to abuse me in filthy language. He started physical assault upon me. That the said accused person Rajiv Kumar Mahato hit me on my chest, neck, back, hands, wrists and tried to hit me on my private body parts with an intention to kill me. That on seeing such an attempt to kill me my wife namely Gaytri Mahato tried to stop my younger brother and his wife but, they also started to hit her on her face and back. That due to such physical assault, I have found severe injuries (both internal and external) on my body. That I was severely and grievously injured, I rushed to the District Hospital Siliguri for my treatment and received the prescribed medicines from experts. That the above noted accused persons have also made the same attempt to injure my


