- One nylon bag containing twenty (20) packets fire crackers of each packet containing 05 (five) boxes i.e. total
 (20 x 05) = 100 boxes of fire crackers styled as "JUGMUG CHOCOLATE JUNIOR" and twenty (20) Packets of
 fire crackers each packet containing 05 (five) boxes i.e. total (20 x 05) = 100 boxes of fire crackers styled as
 "RHINO POWER CHOCOLATE", total weight 17.992 kg.
 - One nylon bag containing eight (08) packets of fire crackers styled as "KING KOBRA FIRE CRACKERS" total weight 19.174 kg.

1, SI Goutam Mallick of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Abhishek Kumar (25), S/O Suraj Kumar Sah of Bankatik, PS. Baikutpur, Dist. Gopalganj, Bihar to the effect that on 17.10.2024 at 20.50 hrs I received a specific source information that one person carrying huge quantity of illegal fire crackers without any valid license is standing at Siliguri Junction, infront of Joy Matadi Bus Counter under Pradhan Nagar PS and waiting for a Bihar bound Bus. Accordingly, I share the information with you and noted in GD book vide Pradhan Nagar PS GDE No. 946 dated 17.10.2024.

As per your kind order and direction, I accompany with ASI Prabal Sarkar, ASI Biplab Kr. Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Siliguri Junction, infront of Joy Matadi Bus Counter under Pradhan Nagar PS, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I also contact with one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling over mobile phone and requested him to come to Siliguri Junction under Pradhan Nagar PS, Dist.- Darjeeling with his video camera for the purpose of videography, if required. I briefed all the Police personnel sharing the information in hand and briefed them properly. At around 21.15 hrs we arrived at Siliguri Junction, in front of Joy Matadi Bus Counter under Pradhan Nagar PS and as identified by the source, I managed to detain one person with two nylon bag in his possession. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation he disclosed his identity as noted above and on further interrogation he disclosed that he is carrying illegal fire crackers in two nylon bags and waiting there for a Bihar bound bus with a view to sale the same in Bihar for his illegal gain. On search two nylon bag in his possession recovered the above mentioned illegal fire crackers which were kept conceal inside the nylon bag without any safety measure. On demand he failed to produce any valid documentation from appropriate authorities. The accused person noted above was carried the said fire crackers without any safety measures and without any permission from appropriate authorities. There were every possibilities of accident due to such kind of negligence act by the arrested accused person Abhishek Kumar (25), S/O Suraj Kumar Sah of Bankatik, PS. Baikutpur, Dist. Gopalganj, Bihar that may cause loss of life and properties of the area. Accordingly, I seized the above mentioned illegal fire crackers from the procession of Abhishek Kumar (25), S/O Suraj Kumar Sah of Bankatik, PS. Baikutpur, Dist. Gopalganj, Bihar under proper seizure list in between 21.40 hrs to 22.05 hrs under the coverage of videogray by the above mentioned videographer as per norms of BNSS and subsequently, arrested the above mentioned detained person namely Abhishek Kumar (25), S/O Suraj Kumar Sah of Bankatik, PS. Baikutpur, Dist. Gopalgani, Bihar after observing all sorts of formalities and inform him about the ground of his arrest.

Under the above circumstances, I pray before you that a specific case under proper section of Law may kindly be started against accused namely Abhishek Kumar (25), S/O Suraj Kumar Sah of Bankatik, PS. Baikutpur, Dist. Gopalganj, Bihar under proper section of law and may arrange to cause its investigation.
