Respected Sir,

I, Sarifa Khatun, daughter of Md. Safiul Rahaman, resident of Salbari Naya Busty, PS – Pradhan Nagar, under Champasari Grampanchayat, Dist – Darjeeling, begs to inform you that my father Md. Safiul Rahaman, son of Late Sulaman Haque, resident of Salbari Naya Busty, PS – Pradhan Nagar, under Champasari Grampanchayat, Dist – Darjeeling is the absolute recorded owner in possession of land measuring 8 decimal or 5 katha situated at Mouza – Udaysingh, JL no. 51, forming part of RS plot no. 82, recorded in LR khatian no. 105, forming part of LR plot no. 117, PS – Pradhan Nagar, Dist – Darjeeling, by virtue of a patta issued by the BL and LRO Siliguri And Naxalbari Block vide misc case no. 01(X4) 92 – 93 dated 16/10/1992.

That my father being the absolute recorded owner in possession of land measuring 8 decimal or 5 katha situated at Mouza – Udaysingh, JL no. 51, forming part of RS plot no. 82, recorded in LR khatian no. 105, forming part of LR plot no. 117, PS – Pradhan Nagar, Dist – Darjeeling and is holding, occupying, enjoying and possessing the same in his khas and actual physical possession and duly constructed a boundary wall over the said land and also put an iron gate over the same.

That today at about 1.30 p.m. the above named accused person along with 10 to 15 anti-social elements of the locality came to illegally encroach the aforesaid land of my father with their illegal means.

That my father along with my sister-in-law namely Hasina Khatun and Asma Begam and my sister namely Rameja Khatun raised strong objection to such illegal acts of the aforementioned accused persons for which they became furious and hit us with fits and iron rods and thus I sustain injuries, not only that the aforesaid accused person namely Anarul Islam with intent to outrage my modesty touched me inappropriately and torn my clothes.

That one of the aforesaid accused person namely Mafujar Rahaman snatched gold chain of worth Rs. 50, 000/- from the neck of my sisters-in-law namely Hasina Khatun.

That due to the strong objection and resistance of my father, sister-in-law and my sisters, the aforesaid accused person fail to fulfill their ill intention and unable to encroaching the said land of my father but while leaving the spot the aforementioned accused persons threatened that they will come again and will encroach the said land illegally by any means.

Sir, I, therefore request you to look into the matter and take necessary legal action against the above named accused persons and I will be highly obliged to you for kind perusal and necessary action.
