I the undersigned would like to inform you that I am the legally married wife of Sri Amrit Prasad, son of Sri Surendra Prasad, resident of Upper Bagdogra, Jyoti Nagar, near Shivmandir, P.O. & P.S. Bagdogra, District – Darjeeling and the said marriage was solemnized on 03.12.2019 in accordance with the Hindu rites and customs at Sanyasi Temple, Bagdogra.

I would like to further inform you that after the said marriage, my husband has brought me in my matrimonial house as stated above and we started to reside there alongwith my father-in-law Sri Surendra Prasad, mother-in-law Smt Dukhini Devi, elder brother-in-law Sri Subhash Prasad and one unmarried sister-in-law Manisha Prasad in a joint mess.

I would like to further inform you that from the very inception of the said marriage my husband and above-mentioned in laws, all have started to put pressure upon me to bring money of a sum of Rs. 20,00,000/-(Rupees Twenty Lakhs only) from my father for starting a new business of my husband and elder brother-in-law but I tried to convince my husband and in laws that my father is not in a position to fulfill their said demands due to his financial inability and due to such refusal to fulfill the said demand, my husband with the instigation of my in laws assaulted me brutally on several occasions and for that I sustained injuries in the different parts of my body and it is more painful for me that after sustaining such injuries my husband and said in laws did not bother to bring me to hospital or any physician for my treatment and moreover they used to compel me to stay in a room without any meal and water by putting the padlock from outside the said room. But being the newly wedded wife, I somehow swallowed all the pain with a hope for a better conjugal life.

I would like to further inform you that after elapsing of few months from the date of the said marriage, I could realize that my husband is a habitual drunker and he also takes contravened drugs and with the impression of such drugs, my husband used to torture me physically on the various pretexts which cannot be uttered. Due to such inhuman torture and seeing my agony, my unfortunate father started to pay the amounts as per the demand of my husband and my elder brother-in-law and on several occasions, my father has paid the considerable amount to my husband and my elder brother in law in cash and through bank just to see me happy and smile on my face.

I would like to further inform you that in the month of February, 2020 I got pregnant but my husband and in laws refused to give any attention to me in regard to my health and medical checkups and moreover in that situation my husband did not spare me for continuing the physical abuse and on that score, I was compelled to leave my matrimonial house and take the shelter in my paternal place in the month of July, 2020 just after some relaxation were provided during Covid-19 Pandemic and its lockdown, only to save the feotus in my womb. Thereafter my parents have taken all the steps for my health and on 23.09.2020, I gave birth to a female child but it is very unfortunate that during this period and even after the birth of my new born baby, my husband and my in laws did not bother to see me and my new born baby and the question of spending the money for my delivery and other expenses was too far.

I would like to further inform you that on the first birthday of my daughter, my husband came to my paternal place in a drunken condition and started to abuse filthy languages stating that he is not the father of my child and daughter has no value in their family and he also leveled the allegation that if he would be the father of that child, definitely the child would have been male and on protest as made by me against such baseless allegation, he started to physically assault me by fist and blows and he tried to snatch the said milk sucking baby with intention to kill her and in the meantime, my parents tried to resist him but he became more violent and he also assaulted my old parents and thereafter he left the said place.

I would like to further inform you that thereafter on several occasions, my husband came to my place and somehow convinced me to take money from my father for his hardship. On one occasion, my husband came to me and stolen my fold jewelries and subsequent to that I came to know that my husband sold the said jewelry. Few days back, the Pradhan of Bagdogra Panchayat, who tried to reconcile the matrimonial dispute between me and my husband, she informed my mother and warned her to keep me and my daughter in a safe condition as because my husband and in laws may harm us to any extent.

I would like to further inform you that yesterday i.e, on 18.10.2024 at around 6 p.m. in the evening when I was present in a nearby Champsari Market for shopping fruits and vegetables, my husband came behind me from back and by grabbing my neck he slapped over my face and threatened me with dire consequences that he will not hesitate to kill me and my minor daughter. After the said incident, I became very shocked and fell ill and somehow I a managed to return to my paternal house and informed my parents about the incident.

Under the above circumstances, I would like tor reuest you to investigate the matter and do the needful for the ends of justice.
