I Gaurav Dey, son of late Gautam Dey (Aadhar no – 71020970341) resident of 69 Ramkrishna Road Ashram Para, Siliguri, Ward no – 14, Pincode – 734001, Dist – Darjeeling, West Bengal. Ph – 8509483083.

On Thursday, 10th of October 2024, I was invited at my friend's house (Sabarna Bhattacharaya) in an occasion of Durga Puja located at Ruchi 2 apartment, Nivedita Road, by lane, landmark Radha Swami Mandir, Pradhan Nagar. Around 10 pm I was returning to my house, the guard of that apartment, Dipak Basnet was using abusive and filthy language to my friend Sabarna Bhattacharaya, I warned that guard about his behaviour but he still continued and abused my parent in a vulgar language. All of a sudden he got a Khukri (Large Knife) and then he used it as a weapon and ran it through my nose which resulted my nose tip to fell off and then he swunged it me on my neck but fortunately I was able to protect myself with me left hand and it got injured too, then he bit me on my right thigh, all of these cause severe bleeding. As a proof I am placing all the photographs, videos and medical reports along with the FIR.
