That since November 2022 my husband fell ill and slipped into coma. Thereafter my husband was under continuous treatment and passed away on 3rd day of July 2023 at Asian Institute of Gastroenterology Private Limited, Hyderabad. After the demise of my husband my mother-inlaw and my sisters-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty started to break me mentally with the intention to out shed from my matrimonial course despite knowing the fact I am a widow and surviving with my minor daughter. My mother-in-law and my sisters-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty assaulted me with slaps and forcefully out-shed me from my Smt. Sima Chakraborty assaulted me with slaps and forcefully out-shed me from my smatrimonial house along with my minor daughter. I was begging for mercy before my mothermal-law and my sister-in-law's as I am a widow and I have a minor daughter with me but my mother-in-law and sister-in-laws did not pay any heed to it. On several occasion I tried to enter my matrimonial house with my minor daughter but my mother-in-law and sister-in-laws did not let me enter.

On 22nd of September 2024 my mother-in-law called me from +91 8637887574 and asked me to visit my matrimonial house after the end of durga puja. Yesterday on 21st of October, 2024 at around 07.45pm in the evening when I visited my matrimonial house with my minor daughter, I found that my mother-in-law and my sister-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty were already present. As soon as I entered my matrimonial house, my sister-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty all of a sudden abused me with a very filthy word which lowered my dignity. When I raised my voice upon such derogatory word my mother-in-law without any rhyme and reason slapped me. Thereafter, my sister-in-law namely Smt. Jhuma Bhattacharjee passed a bottle of kerosene to my mother-in-law and my mother-in-law poured upon me. Said Smt. Dolly Saha and Smt. Sima Chakraborty provoked my mother-in-law to burn me alive saying "o more gelei amader somossar somadhan hobe." Upon getting the smell, when I tried to scream, Smt. Jhuma Bhattacharjee and Smt. Sima Chakraborty chocked my throat and threatened me to death if I ever come to my matrimonial house to reside with my minor daughter. When my daughter tried to save me my sister-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty abused my minor daughter with bad words which broke down my daughter mentally. My mother-in-law and my sister-in-law Smt. Jhuma Bhattacharjee stated that after the demise of my husband I and my minor daughter have no reason to live in my matrimonial house. My sisters-in-law namely Smt. Dolly Saha and Smt. Sima Chakraborty pulled my hair and threw me out of my matrimonial house and threatened me with dire consequence, if I try to enter into my matrimonial house. Finding no alternative I and my daughter ran out from my matrimonial house to save my life.

Sir, since my marriage with my husband, my mother-in-law and all my sisters-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty tortured me and did not let me leave a peaceful, conjugal life with my husband. My mother-in-law and my sister-in-law Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty mentally tortured me and my minor daughter and after the demise of my husband out-shed me from my matrimonial house and my mother-in-law and my sisters-in-law Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty tried to kill me by burning me alive.

Upon the said incident happened with me since my marriage, and after I am a widow I am lodging this complaint against my mother-in-law and all my sister-in-law namely Smt. Jhuma Bhattacharjee, Smt. Dolly Saha and Smt. Sima Chakraborty and requesting to investigate the matter and give me justice.
