
Dear Sir,

With due respect I, Sri Budhiman Munda, S/o. Late Sakhi Munda, resident of Panchkalguri, P.o. Nimai, P.s. Matigara, Dt. Darjeeling, would like to inform you that on 29.09.24 at about 5.30 PM (evening) when I along with my son namely Sri Sumit Munda as pillion coming by my motor cycle bearing its registration no. **WB74BA/7818** (Hero Glamour) from sukna to my home at Panchkalguri while I was appeared in front of Mayfair tea resort inside new champita tea estate that time one polo car bearing its registration no. **PB03BC/5641**, at present the owner is residing at **Biharmote, Sukantapally, uttarbagdogra under Bagdogra police station, Dt. Darjeeling** rashly and negligently hit me from my right side as a result I myself and my son fallen in to road with my motorcycle and the particles of glass of the car get inside in to right side leg of my son and cut down the nerve of said leg. Instantly he was admitted in to Navjevan hospital at Ghospukur and thereafter they referred to Neotia Getwel hospital at uttarayan. On 20.10.24 my son discharged from there. From this aforesaid treatment my I have incurred huge amount of money for treatment of my son.

Therefore, I request you to kindly take appropriate step against the driver of above said offending vehicle and driver and kind oblige me. The F.I.R is making in delay due to remain busy in my son's treatment.
