- 2. I the above named individual is serving with HQ Chief Engr Siliguri Zone since Feb 2024 and staying with my family in government provided married accommodation No KP23/C at KP quarters. I was on leave from 11 Oct 2024 to 20 Oct 24 to attend Durga Puja at Home.
- 3. On 16 Oct 24 I came to know through a tele call from my neighbour that a robbery has been taken place in my quarter by some unrecognised person on 16 Oct 24 in between 0830 hrs to 1330 hrs. On return from leave on 19 Oct 24, I have realised the fwg items have been lost from my quarter:-
 - (a) Rs 25000/- (Rupees Twenty Five Thousand only)
 - (b) Gold Necklace with pendant costing Rs 75000/-.

(c) Gold earrings costing Rs 15000/-

(d) Chairos Wrist Watch costing Rs 40000/- (Approx).

(e) Sky Bag (Black Color)

- (f) Grocery Items costing more than Rs 3000/- purchased from CSD for day to day use.
- 4. I have informed the matter to my senior officer as well as Military Police.
- 5. Here it is also submitted that all the four houses of the entire block (KP-23) was simultaneously robbed in broad day light.
