Bhaktinagar, District- Jalpaiguri, PIN- 734001 in the State of West Bengal, would like to lodge this Written Complaint before your good office to the effect that I am an old aged person and I have two sons and one daughter and my elder son namely **Sri Kundan Jha**, since last 6-7 years my above mentioned elder son tortures me and my wife on regular basis.

Sir, he consumes alcohol on regular basis and after consuming the alcohol he creates nuisance in the house as well as in the society.

Sir, he is a quarrel loving person and he picks up quarrel with me and my wife on regular basis and he does not dare to assault us physically and he also abuse us with a filthy and abusive language.

Sir, it is to be mentioned here that the wife of my above mentioned son has also filed a Criminal case under various sections of I.P.C. against my above mentioned son.

Sir, today from the early morning my above mentioned son was continuously harassing us and at about 02:00PM he assaulted my married daughter and my wife very badly and when I went for the rescue of them, the above mentioned son attacked upon me with vegetable cutting instrument (bothee) with an intention to kill me but somehow I managed to save

myself from his clutches and finding no other alternative call the Police van and thereafter I went to Siliguri District Hospital for treatment.

Sir, it is to be mentioned here that the above mentioned person wants to capture my property.


