In producing herewith 03 (Three) arrested accused persons namely (1) Prem Ray-29yrs s/o Ramesh Ray of Jyotinagar near Gas Godown, ward no-41 PS Bhaktinagar Dist Jalpaiguri (2) Rahul Ahuja-25yrs s/o Lt Chetan Ahuja of Chayanpara, near Damping ground, PS Bhaktinagar Dist Jalpaiguri and (3) Sumit Das-19yrs s/o Anil Das of Bottle company ward no-41 PS Bhaktinagar Dist Jalpaiguri arrested on 23.10.24 u/s- 35 (1) BNSS along with following seized articles viz: -

- 1. One iron made sharp cutting knife approx 12" recovered from the exclusive and Conscious possession of Prem Ray which was kept on his right hand.
- 2. One iron made hammer with wooden handle having weight approx 300 grams recovered from the exclusive and Conscious possession of Rahul Ahuja which
- 3. One iron made "sickle" measuring about 13 inch (approx) with wooden butt from the possession of accused Sumit Das which was kept on his right hand.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 23.10.24 at 00.35 hrs received a sources information that 8/9 youths have assembled at P.C Mittal bus stand under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No. 1178 dated 23.10.24 Subsequently after sharing the information with my superiors and as per their direction, at 00.40 hrs myself along with SI Yugel Lepcha, SI Rantu Halder, ASI Dipak Karmakar, ASI Khagen Barman, C/374 Debraj Biswas and ASI Ratan Sarkar with force (K-38) along with kits left for the place to work out the information. This refers to Bhaktinagar PS GDE No- 1179 dated 23.10.24. We reached at P.C.Mittal bus stand under Bhaktinagar PS at 00.45 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 03 (three) accused persons along with seized articles as mentioned above. However, the other 5/6 persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area. They also stated that another six others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 00.55 hrs to 01.10 hrs) Thereafter, I arrested the above noted accused persons u/s 35(1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them. Seizure process duly audio & video graphed.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Prem Ray-29yrs s/o Ramesh Ray of Jyotinagar near Gas Godown, ward no-41 PS Bhaktinagar Dist Jalpaiguri (2) Rahul Ahuja-25yrs s/o Lt Chetan Ahuja of Chayanpara, near Damping ground, PS Bhaktinagar Dist Jalpaiguri and (3) Sumit Das-19yrs s/o Anil Das of Bottle company ward no-41 PS Bhaktinagar Dist Jalpaiguri and six others and arrange for its investigation.
