I **Rohit Gupta**, Son of **Mukesh Chandra Gupta** resident of Gurung Basti, Durga Nagar Colony, Siliguri. Owner of a shop Located in Mallaguri more named Gupta Restaurant would like to report a serious incident of Robbery and assault that took place on **21st oct' 2024** at approximately **11:00 P.m.** While I was present at my shop, **Badal Ram Son of Baleswar Ram** resident of Mallaguri railway line and 15 individual forcefully entered and attacked me and my staff, During the attack, they abused me and robbed my gold Chain and approximately 10000 cash from my pocket and they were with knife & Sword etc. Despite the severity of the situation, I managed to escape and survived the attack, but the trauma and Financial Loss have been immense.

I Kindly request you to Register an FIR and take immediate action to investigate the matter. I have CCTV footage and ready to provide any further Information.
