disclosed our identity to the person inside the vehicle and asked him to step outside of the vehicle but the person inside the vehicle turned on the engine and tried to flee away from the spot. But on hot chase, myself along with team detained the vehicle and apprehend the person inside the vehicle. The whole process of seizure & label and arrest was made between 14:45 hrs to 15:50 hrs and was videographed.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the above noted accused person namely Ainul Miah (34) S/o Pirmamud Miah of Gheghirghat, Dewan Hat PS Kotwali Dist. Coochbehar and arrange for its investigation.
