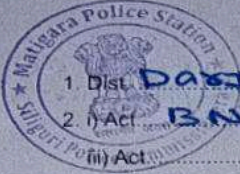

Sir,

In producing herewith one arrested accused person namely Bharat Kumar (47 yrs approx), S/O- Lt. Bijadhar Kumar of Khaprail Bazar, PO- New Chumta, PS-Matigara, Dist-Darjeeling and the following seized articles under proper seizure list -

- 1) 32 bundles of 'Kobra' marked chilly fire crackers containing 50 packets in each bundle.
- 2) 30 bundles of 'Assam Lion' marked chocolate fire crackers containing 5 packets in each bundle.

I, SI Shib Shankar Das of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that today on 23.10.2024 at 18:05 hrs I received a secret information that one Bharat Kumar (47 yrs approx), S/O- Lt. Bijadhar Kumar of Khaprail Bazar, PO- New Chumta, PS-Matigara, Dist-Darjeeling has stored huge quantity of Fire-crackers at his house at Kaprail Bazar for selling the same in the open market for his wrongful gain without having any license or any other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. This refers to Matigara PS GDE No- 1262, dated- 23.10.2024. Accordingly, as per your kind order I along with ASI- Pema Dorjee Sherpa, ASI Chandra Prakash Adhikary, C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all are of Matigara PS, SPC rushed to the spot to work out the information.

On reaching at Khaprail Bazaar, I contacted with my source and being guided and identified by the source we proceeded towards the house of the above noted accused person. Accordingly, I searched his house in presence of local witnesses and found the above noted seized articles being stored in his house without any precautionary and safety measures. On being asked Bharat Kumar could not produce any valid document for above mentioned fire crackers. Accordingly I seized the above noted articles with the help of my police team under proper seizure list in presence of independent witnesses and arrested the above noted accused person namely Bharat Kumar (47 yrs approx), S/O- Lt. Bijadhar Kumar of Khaprail Bazar, PO- New Chumta, PS-Matigara, Dist-Darjeeling under proper memo of arrest.

There is a reason to believe that Bharat Kumar (47 yrs approx), S/O- Lt. Bijadhar Kumar of Khaprail Bazar, PO- New Chumta, PS-Matigara, Dist-Darjeeling has stored the said consignment of fire crackers for selling the same in the open market for his wrongful gain, which are combustible in nature and endanger to human life and property at his house illegally and violating Govt. Orders. Moreover, the above noted fire crackers were stored without any precautionary and safety measures. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses. The whole process of seizure was made between 18:30 hours to 18:45 hours under videography.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the arrested accused person namely Bharat Kumar (47 yrs approx), S/O- Lt. Bijadhar Kumar of Khaprail Bazar, PO- New Chumta, PS-Matigara, Dist-Darjeeling under proper section of law and arrange for its investigation.
