I, Bijay Lakra, (s/o- Bernard Lakra), Divisional Engineer (S&LP), Darjeeling Region do hereby lodge this complaint to the effect that today (23.10.2024) at 14:09 hours regarding theft of electric energy found during routine inspection by myself along with Bhaben Roy, SO (S&LP), Darjeeling Region, Mr Prashanta Kumar Mahato, AE&SM Midnapally CCC and other technical personnel had been to the spot at South Bharatnagar, Ward No.-24 near Municipality Building Centre, in the house of Mr. Goutam Mukherjee. After issuing notice to the representative of Mr. Goutam Mukherjee, we check the departmental meter (No.: BE0386219 and ID No: 401376389) found that his domestic connection was issued to him. Subsequently, due to non-payment of outstanding dues of Rs 11,845 line was disconnected on 03.07.2024.

On physical inspection, it has been detected that said Mr. Goutam Mukherjee reconnected the line with the WBSEDCL energy and enjoying the electricity energy since 03.07.2024 unauthorizedly without paying a further to this company in which the company is facing financial losses.

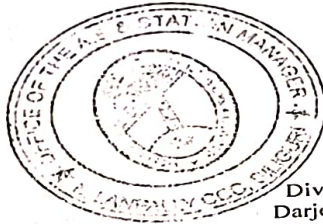
He did this intentionally, motivatedly with malafied intention for his wrongful gain. As Mr. Goutam Mukherjee, South Bharatnagar, Ward No.-24 near Municipality Building Centre has committed an offence, punishable under section 135(1) (a) and 138(1) (b) of Electricity Act, 2003. So, I, prepared inspection memo and seizure list by seizing the meter in-question in presence of witnesses and supplied copies of it to the representatives of the premises owner. The contractual load of meter is 0.7 kva final reading of meter is found 2086 ckw. h.

So, it is requested to start a case u/s 135(1)(a) and u/s 138(1)(b) of Electricity Act 2003 (Amendment Act 2007) against Mr. Goutam Mukherjee, s/o- Lt Chittaranjan Mukherjee and arrange for its investigation.
