would like to inform you that on 22/10/2024 at about
4.30 P.M. while I was going towards Rajiv More,
Ashrampara, siliguri, from Amtala club siliguri Ashrampara
in Bike, suddenly a vehicle being No- WB73E-6859, a
School Bus Delhi Public School, Fulbari, coming from
the opposite direction i.e from Rajiv More towards
Amtala club. Ashrampara, driving the vehicle very
rashly and negligent manner dashed me while I was
standing by the side of the road in front of Amtala
club More. I fall down on the ground with vehicle (bike)
and sustain several injuries all over my body, on my
