Sir,

I, Mrs. Dicky Chomu Pradhan, W/O Mr. Kishore Pradhan working in the post of Assistant Engineer(Civil), Civil Construction Wing, All India Radio, 2nd Mile, Sevoke Road, ITI More, Siliguri would like to inform your good self that today morning I found the lock of our old office at AIR Transmitter complex, 3rd Mile, Salugara found broken and some materials were missing. Actually in the same building there were two offices (i) Office of the Executive Engineer(Civil) which has been shifted to Kolkata and (ii) Office of the Assistant Engineer(Elect) shifted to S/Qtr. At Studio complex, All India Radio, ITI More, Siliguri. However some store / Scrap material / Furniture were kept in both of the offices. Some unknown person(s) broken the locks of both the offices and taken away the following materials.
