I O.P. Bhandari, an Advocate, Vice-President of Sikkim High Court Bar Association would like to inform you that on 27th of August, 2024, I went to Amritswar & Chandigarh with my family parking my private Ford ECO- Sport Car No.SK-01PA7552 at my house located at Debidanga, Siliguri, Opposite Anchal Office. Sir, we returned back from Chandigarh on 30th August 2024 since we reached Siliguri lately as such we stay at our house at Debidanga that night and on 31st August, 2024 we went back to Gangtok in our ECO-Sport Car, No.SK-01PA7552 at about 7-00 a.m. in the morning well reaching 2-kilometers away from Bengal Safari Zoe, we have suddenly notice the smoke and fat-fat-fat sound coming out from front site of Car and after noticing it my driver Rapzang Tamang stop the vehicle and we came out from the vehicle to see the problem of the vehicle, my driver switch off the car and again switch on to check the problem, but again same problem appear and after sometime vehicle stop starting since I was with my family i.e. my wife Sabitri Bhandari, my daughter Divya Bhandari, my son Janishhye Bhandari and house-hold goods loaded in it. When our vehicle suddenly stop plying we are in great problem and confused what to do luckily my driver Rapzang Tamang told that he had phone No.of manager ford workshop of Sikkim(Manager) and I call him and informed about the sudden problem occured in our vehicle 2-kilometers away from Bengal Suffari going towards Sikkim and he forwarded the phone No. of manager Ford Workshop of Jyotinagar, 2nd Mile Kuldeep Singh through wattsap, so that I am able to call Kuldeep Singh Manager of Banshal Automotives Jyotinagar, Siliguri about the problem and after sometime he told me that you will sent vehicle carrier truck which ~~xxxx~~ charged 3500 Rupees to lift my vehicle from the place it stop and to take upto Banshal Automotives situated at Jyotinagar, Siliguri, agree to pay the said amount and after sometime our vehicle lifted in the said truck and I alongwith my family to went upto Banshal Automotives in the same lifted vehicle and after reaching the workshop it was on loaded and parked infront of the workshop.

Sir, since I was with my family and with several house-hold items in the vehicle which can not be kept long which can become unworthy to use things like fluits and vegetables as such I requested the manager of Banshal Automotives to check the problem of my vehicle after my coming back within 2-days from Gangtok by dropping my family and house-hold items, but the manager refused the request made by me to check the problem of the vehicle after 2-days and told me that he can not wait long, if I have got the faith with him then leave the vehicle if not he is unable to ~~except~~ accept it since vehicle ~~xxxxx~~ was not in condition to ply I was compelled to leave the vehicle in their custody and I have booked one Sumo(Tata) from Siliguri Junction at the cost of 4,000/- to go upto Gangtok and I alongwith my family loaded with the house-hold items taken out from my vehicle left for my house located at Tadong, Sikkim.

Sir, after 4-days back of our reaching home at Gangtok one Mandeep Singh, he himself introduce as advisor of the said workshop call me and even sent me wattshap message to sent the advance money to start the work of my vehicle bearing No.SK-01PA7552 and I was in a great need of my vehicle I have sent the sum of Rs.15,000/- in the Bank Account of Banshal Automotives in State Bank of India on 05/09/2024. The same person through his phone No./Wattshap No.9564068562 informing me ~~ba~~ that some parts are needed to replace to resolve the issue of my vehicle which are as follows :-

- 1) Injector 1nos.cost 22515/-
- 2) Injector bush.1No.cost- 80/-
- 3) Injector washer 1No.cost-314/-
- 4) Injector return Pipe cost-2969/-
- 5) Battery - cost -4580/-
- 6) A mounting cost-5252/-

In totality Rs.35710/- excluding labour charge and the said person named as Mandeep Singh sent the message through his wattsap to approved for the total amount necessary for replacement of New Parts & I without any Objection approved the same.

Sir, it is very suspicious that manager Kuldeep Singh told me that they can not ~~wait~~ wait even ~~to~~ 2-days after my coming back from Gangtok, but they detained my vehicle 18-days in their workshop with the plea that they have ordered the parts from Chennai, the intention of telling me that he is not unable to wait long and detaining my vehicle more than 18-days itself is note worthy and suspicious.

Sir, I have ~~am~~ enquired about the completion of my vehicle repairing after the gap of day or two, but Mr. Mandeep Singh used to told me that they are waiting for some parts to come from Chennai on 16/09/2024 I again call Mr. Mandeep Singh about the status of my vehicle and on that day he told that the repairing of the vehicle is completed and I told him can I come on 17th day of September, 2024 on the day of Biswakarma Puja, he said normally they will not release any vehicle on the day of Bishwakarma Puja, but he told me to come and received the same and I alongwith my family came to received it on 17/09/2024 and Mr. Mandeep Singh take out the long list of Bill and amounting to 29,720/- excluding advance amount send by me in their account on 05/09/2024 in totality the some of Rs.44,720.23 without any objection and received the vehicle and went back to Gangtok on same day and immediately on 24/09/2024, I went to attend one Civil Defamation case in favour of ~~2~~ JACOB Khaling, Political Secretary to Chief Minister of Sikkim after his evidence reaching near my house my son, who was looking towards the road ~~am~~ noticed the smoke and the same sound coming out from the vehicle only after 7-days ~~xxxx~~ from the day of taking the vehicle from the workshop and we have checked again whether the same problem appear from the vehicle on our enquiry it is detected the similar problem.

Sir, on noticing the same problem I immediately call Mandeep Singh and Kuldeep Singh about the same, but they said the problem may be from different parts not from the one in which we have repaired even I informed Secretary to the Chief Minister of Sikkim, Mr. S.D. Dhakal & he too talk to the Manager about the same and even I with good faith informed some of the Police Officer of Sikkim to help me to talk to the Police Officer of Siliguri to resolved the problem without filing this F.I.R. but inspite of several efforts to resolve the problem without taking severe steps, but all my efforts where failed hence I am ultimately compelled to file this F.I.R. for Commission of offence of cheating, ~~tax~~ fraud, mischief & defficiency of Service of Banshal Automotives. They can not ~~stop~~ escape saying it may be the different problem not the previous one since vehicle was parked and kept in their custody for 18-days it was their duties to through Checkup of all the ~~problem~~.
