Subject: To complain about a driver and his friend who assaulted, hit and threatened many people including me in the neighbourhood of Ramchandra Nagar.

Respected sir,

I Bharat Prasad Gupta s/o Late Paras Nath Gupta, r/o Ramchandra Nagar, Siliguri would like to appraise you that an unfortunate event occurred when I was coming home from my office and on the turn towards my home, I was not given side by a driver named Prabhakar chhetri s/o Deepankar chhetri r/o Paswan busti upon which I asked him to park his vehicle bearing no. SK 05 J0126 in a manner no one was obstructed, upon which he along with his friend named Rakesh Rai, s/o Late Dipak Rai r/o Limbu Basti caught my neck and abused me. The neighbours Mr. Santosh Sha and his wife Mrs. Pinky Sha when tried to resolve the matter they abused him and brought a Rod and lever to hit them. They also trapped the family members of Mr. Santosh Sha in their house for an hour and threaten them that they both will kill them.

The crowd gathered to resolve the fight and they both threatened to hit anyone who come their way meanwhile they hit Mr Abhinash Pathak, Mr. Ronit Singh and Mr Basudeo Prasad with rod aiming at their head but Abhinash block the Rod with his hand and saved himself. The assault was so severe that Mr. Abhinash would have died if that rod would have hit him on his head. Actually, it was an unsuccessful attempt to murder. Being unsuccessful in their attempt to murder these ssdriver & his friend started using slang language and they used very disrespectful language toward many women including Mrs. Pinky Sha which totally outrage the modesty of all women present there. Finally, many neighbour call police repeated and It was that only after arrival of Police that the situation was brought under control. Now, the situation of my area i.e, Ramchandra Nagar, Ward No 42 is totally filled with fear and every villagers is in fear to come out of their home.

When the event was reported to the authority, they continued their attacks and threatened

Me and many others who tried to stop their fight that upon granting bail they commit to come back and murder all the person involved in stopping their attacks.

Therefore, I request you to kindly lodge an F.I.R and take this event very seriously as this effects almost all people of my area.
