Subject:- Request regarding misuse of Jalpaiguri District Ball-Badminton Association letter-head with my fake signature or misuse of all documents.

Respected Sir,

I, Sabina Khatun, D/O-Md-Ibrahim & W/O-Faisal Ahmad, residing at Lower Bhanu Nagar, Lenini Sarani Road, ward No-43, Siliguri, would like to bring the following to your attention.

I was married to Faisal Ahmad on 23/06/2024 and he physically and mentally tortured me for dowry. On 04/08/2024, he threw me out of the house and did not allow me to take any belongings, including my school documents, college documents, my ID (Ball Badminton Association of W.B.), the letterhead stamp of the Jalpaiguri District Ball Badminton Association, the letterhead stamp of the Soft Cricket Federation of India (W.B Soft Cricket Association), and documents related to the 15th Constituency of Parliament Election 2024 which I contested. I have no idea what he did with these documents and whether he has misused them.

Today, on 23/10/2024, I received a notice from the Ball Badminton Association of West Bengal stating that I had misused the sports letterhead, but I have not done anything of the sort, nor am I aware of it. I entered the sports field at Faisal Ahmad's misusing all insistence, but when I felt things were wrong, I left it. Now, Faisal Ahmad is misusing all the documents to implicate me and is even using my fake signature. If any of these documents are misused in the future or my fake signature is found, I will not be responsible. Faisal Ahmad will be responsible as all the documents are with him, and he had also threatened me that he would trap me, which has been proven today. To prevent further wrongdoings against me, I am informing the Police Administration.

Therefore, I request you to kindly initiate legal proceedings against the accused for the sake of justice. A photocopy of the B.B.A.O.W.B notice is attached.
