I, **KALYANI ROY**, wife of Sri, Nemai Roy, Permanent Address Vill-
Kawakhali, P.O. Sushruta Nagar, P.S. Matigara, Dist- Darjeeling, would like to inform you
that as follows.

1. That **ANIL CHANDRA ROY**, son of Late Amulya Roy, residing at Vill- Kawakhali, P.O. Sushruta Nagar, P.S. Matigara, Dist- Darjeeling, is my Brother - in -law he resides along with me and my husband at my above mentioned residential address.
2. That yesterday **23.10.2024 at about 3:10 PM** while my brother in law was sitting at veranda of my above mentioned residential address suddenly three persons name (i) **Gopal Debnath**, Son of Late Satish Debnath, Vill- Kawakhali, P.O. Sushruta Nagar, P.S. Matigara, Dist- Darjeeling Vill- Kawakhali, P.O. Sushruta Nagar, P.S. Matigara, Dist- Darjeeling (ii) **Mangal Debnath**, Son of Gopal Debnath Vill- Kawakhali, P.O. Sushruta Nagar, P.S. Matigara, Dist- Darjeeling and (iii) **Partha Pratim Dey**, Hakimpura, P.O. & P.S. Siliguri, Dist- Darjeeling, who happens to be my neighbour attacked my Brother- in- law on his head with iron road unnecessary by saying that "To I will kill you as I want to occupy your land ". He assaulted my brother- in-law several times on his head and person with intent to kill him. As a result my brother -in- law fell on ground and fainted. Due to heavy bleeding and several brutal injuries, my husband and with the help of neighbors admitted him to North Bengal Medical College and Hospital immediately. Now he is in serious condition. Said **Gopal Debnath, Mangal Debnath and Partha Pratim Dey threatened me that they kill my whole family within short time.**
