With due respect, I, Amina Rizal , w/o. Nishal Rizal, R/o. Devidanga near Ganesh Mandir, P.O Pradhan Nagar, P.S- Pradhan Nagar , Dist – Darjeeling, would like to lodge a FIR against one person named Pravesh Rai, S/o. unknown, Co-Founder of New Shristi Foundation, Anchal, Champari, R/o. Anchal, Champasari, P/o. Pradhan Nagar , Dist – Darjeeling, stating as follows-

- 1. That on 20<sup>th</sup> October 2024 when I reached home at 9 pm I found that my daughter is missing from home.
- 2. That I received a message from my daughter that her friend mother is sick and have no one to help so I am helping my friend caring her sick mother.
- 3. That on 23<sup>rd</sup> October 2024 I came to know that the abovenamed person Pravesh Rai had visited my home on 20<sup>th</sup> October 2024 in my residencein my absence and forcefully taken away my daughter with him. The abovenamed person Pravesh Rai is 35years and is involved in such kind of abduction of minor girls who have just turned 18 so that he will not be accused for his criminal intention of human trafficking.
- 4. That I went to his residence New Shristi Foundation where I found his phone number and in the conversation with him over mobile phone he accepted that my daughter is in his custody.
- 5. That finding no other alternative I have come under your shelter i.e. Pradhan Nagar Police Station for justice for all the suffering I am going through.

I would be grateful if the concerned authority may take immediate and necessary action to the earliest. The arrest of the abovenamed persons i.e Pravesh Rai and friend co-founder of New Shristi Foundation is ultra-necessary to prevent the ongoing anti- social activity and to eradicate any future plotting and planning against any such innocent daughter as mine in the society at large.
