1, Sri Subhankar Narayan Bose, Son of Late Soumendra Narayan Bose, one of the partners of S. N. Bose & Co., a partnership firm, having its registered office at Gayaram Building, Hill Cart Road, Siliguri, Post Office & Police Station – Siliguri, District – Darjeeling, Pin – 734001, beg to lodge this complaint as under:

Date: 25.10.2024

- 1. That since the month of February, 2016, Sri Nirmal Khawas, Son of Late Padam Kr Khawas, resident of Pashupati Sharma Road, Durgaguri, Pradhan Nagar, Post Office & Police Station Pradhan Nagar, District Darjeeling, Pin 734003 has been working in our firm as Cashier. His job is to receive and payment made in cash and also diligently maintain the cash books.
- 2. That our firm is the distributor of Kerosene Oil and said Sri Nirmal Khawas used to receive all the cash moneys from the sale proceeds of Kerosene Oil.
- 3. That in the meantime, our said Kerosene Oil business had come to a halt from the month of November, 2023 and in the month of January, 2024 while checking the account books especially the cash book, a lot of anomalies were found with regard to the cash in hand and the actual/physical cash moneys present in the cash book as under:
 - (a) On 10.02.2024, the closing day cash as per the cash book was Rs. 40,87,552/-, but it was found that our said Cashier, Sri Nirmal Khawas was in actual possession of cash money of Rs. 2,552/- and thus there is a shortfall of Rs. 40.85.000/-
 - (b) On further enquiry into the past records and entries tallying with the software Tally® and of the cash books and cash receipts books of our Kerosene Oil Depot from the financial year 2016-17 till the financial year 2022-23, it was observed that as a Cashier, Sri Nirmal Khawas was in receipt of Rs. 2,62,495.51P. on account of the sale proceeds of Kerosene Oil on 20.07.2020 and he received the same and entered it in the cash book on 03.08.2020.

However, even with that receipt, the day end total of the cash book was not altered and neither the entry was made in the Tally Software from which it is evident that the receipt entry in the cash book was made subsequently and the same was neither informed, while data entry to the Tally Operator, nor the cash book total was changed. So, the cash in hand should increase by another amount of Rs. 2,61,495.51P.

Accordingly, the total shortfall in cash-in-hand stands at (Rs. 40,85,000/- + Rs. 2,61,495.51P.) = Rs. 43,46,495.51P.

- That on being asked about the explanation of the said shortfall of cash-in-hand of Rs. 43,46,495.51P., our said Cashier, Sri Nirmal Khawas admitted his guilt and took 4. time till the month of March, 2024 to make good the losses of our firm in a meeting held at the office of Saha & Majumder, Chartered Accountants, C-12, 1st Floor, Shelcon Plaza, Sevoke Road, Siliguri on 22nd February, 2024. To that effect he was a signatory to the minutes of the said meeting. When he couldn't arrange the funds within March, 2024, he sought time of further two months vide his letter in his own handwriting dated 15th April 2024. But till date no effective step has been taken by our said Cashier, Sri Nirmal Khawas and presently, he is not attending our office, without any leave.
- Since then, several attempts have been made by contacting him or his family 5. . during his absence at his home in Durgaguri, Siliguri asking him to visit our office and give satisfactory explanation regarding his unsolicited absence for so long, apart from the above financial misappropriation - but to no avail.

From the aforesaid acts and conducts of said Sri Nirmal Khawas, it is crystal clear that he, being our Cashier, has dishonestly misappropriated and grabbed the aforesaid huge amount of money of Rs. 43,46,495.51P. for his illegal gain.

You are, therefore, requested to enquire into the above matter and take immediate steps against said Sri Nirmal Khawas, starting a specific case against him.
