I, DILIP KUMAR SHA, son of Sri. Jamun Sha @ Yamuna Sha, permanent resident of Bottle chowk company, Sastri nagar, ward No. 41 under SMC, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri, at present residing at Berhampura, Rang Gali, near Pappu Studio Gali, P.O. MIT Eng. College, P.S. Berhampura, Dist. Muzaffarpur, Bihar, would like to inform you that as follows:-

- 1. That Sri. JAMUN SHA @ YAMUNA SHA, son of Late Ganga Sha, is my father. He was the permanent resident of Bottle chowk company, Sastri nagar, ward No. 41 under SMC, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri. In the year 27.06.2016 1. RAMESH KUMAR SINGH, son of Lagan Devi Singh, permanent resident of Baikuntha Pally, ward No. 41 under SMC, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, 2. RAMA NAND SINGH, father's name "not known" and 3. ROHIT KUMAR, son of Rama Nand Singh, both are at present residing at present residing at Bottle chowk company, Sastri nagar, ward No. 41 under SMC, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri, and 7 more people were involved in the kidnapping of my above named father. Moreover I was forcefully evicted from my two storied residential building and later they illegally occupied my said building. At present my residential building is under their possession. Subsequently a specific criminal case was initiated against the above named culprits by the Ld. A.C.J.M, vide case No. SLG. P.S. Case No. 537/17, U/s. 363/365 IPC, dated 23.07.2017 and by the Ld. C.JM., vide case No. BKN. P.S. Case No. 881/17, U/s. 365/368/34 IPC, dated 18.09.2017. Both the cases are still pending. Since then I have been residing in my current address. All these years even if I came to Siliguri but I never dared to enter my above mentioned residential building as the above named culprits are known as anti-socials and are infamous for their criminal activities.
- 2. That on 23.10.2024 at about 12.00 P.M. I arrived at my above mentioned residential building at Bottle chowk company, Sastri nagar, ward No. 41 under SMC, P.O. & P.S. Bhaktinagar, Dist. They threatened me if I try to come again at my own illegally occupied residential building they will kidnap me as they did to my father. When I told them that I shall lodge a complaint before police against this incident they replied me that "the police is in our pocket. No one can do anything against us".
