In producing herewith the arrested accused person namely Nakul Paul (54 yrs) S/O Late Baidyanath Paul of Dabgram, near Polytechnic Collage, PS- Siliguri , Dist- Darjeeling under arrest along with following seized articles as per seizure list viz:-

1. 24 (twenty four) Cartoon Box of RHINO POWER Chocolate , marked as Samir's each cartoon Box containing 10 (ten) Pcs each Chocolate Bamb.
2. 01 (one) Chain of Chorsa Electric Craackers which containing of 50 x 28 Peaces, Trade mark K P R Brand.
3. Navrang Colour containg 25 Packets (Red Star Fire Works made in India.

I, ASI. Debasish Das of Siliguri P.S, SPC do hereby lodge this written complaint against accused person Nakul Paul (54 yrs) S/O Late Baidyanath Paul of Dabgram, near Polytechnic Collage, PS- Siliguri , Dist- Darjeeling to that effect that on 26.10.24 at 18.50 hrs I received a secret source information the above noted person was storing and selling huge quantity of illegal Fire Crackers in his shop styled as Sri Guru Dasakarma Bhandar situated at Fuleswari Bazar Ward No. 24, under Siliguri, Dist- Darjeeling for his wrongful gain This information was diarised in Siliguri PS G.D.E No.1309 dated 26.10.24 and informed the fact to the I/C Siliguri PS. As per direction of I/C Siliguri PS, myself along with ASI Subir Sen, ASI Rabin Lama, C/160 Soumen Sarkar , all of Siliguri PS left for Fuleswari bazar to verify the veracity of this information. This refers to Siliguri PS G.D.E No. 1310 dated 26.10.24. After reaching the place of occurrence we cordoned the place and as per identification by source, raid was conducted in the shop styles as Sri Guru Dasakarma Bhandar situated at Fuleswari Bazar after apprehending the above noted accused person who disclosed his identity as noted above and after searching we found the above noted huge quantities of fire crackers stored in his shop and selling the same to the local people illegally for their wrongly gain. On being asked in presence of available witnesses the above noted accused person failed to produce valid papers or license in support of possessing and selling the above noted huge quantities of fire crackers. On further interrogation, he confessed that he had procured the fire crackers illegally and selling the same in locality for his wrongful gain and the said stored fire crackers are combustibile in nature

and endanger to human life. According I seized the above noted mentioned firecrackers in presence of witnesses after preparing proper seizure list duly signed by the witness and also acknowledge to the arrested accused person. Then after I arrested him after issuing a Memo of Arrest. The whole seizure was made in between 19.41 hrs and 20.45 hrs.

I therefore pray before you that a specific case may kindly be initiated against arrested accused Nakul Paul (54 yrs) S/O Late Baidyanath Paul of Dabgram, near Polytechnic Collage, PS- Siliguri, Dist- Darjeeling under proper section of law.
