With due respect, We Md.Irshad S/o Ms.Sagir and Hashir Barkat S/o Md. Islam residing at Venchijote, New Chamta, P.S. Matigara, Dist Darjeeling would like to drag your sincere attention over the below stated incidents by lodging this F.I.R. by enumerating the

following facts-

1. That oneBhanumati Pradhan was the absolute owner of piece and parcel of land measuring 6 kathas by virtue of a deed of sale bearing no. 6705 of 1989 and since then Bhanumati Pradhan was enjoying and possessing the said land having permanent, heritable and transferable right, title and interest therein till her

death.

2. That after her death on 10/02/2008 her son namely Nobin Pradhan resident of Kohima Sadar, Kohima, Nagaland became the absolute owner of piece and parcel of land measuring 6 kathas by virtue of inherence of hindu succession and since then Sri Nobin Pradhan has been enjoying and possessing the said land having

permanent, heritable and transferable right, title and interest therein.

3. That accordingly the concerned BL. & LRO recorded the name of Sri Nobin Pradhan under Mouza - Dabgram recorded in R.S. Khatian No. 96/1

corresponding to L.R. khatrian No. 2587 and in R.S Plot no. 5 and 98

- corresponding to L.R. plot no. 832 and 98, J.L. no. 2, P.S Bhaktinagar, Dist Jalpaiguri.
- 4. That in the year 2024 Sri Nobin Pradhan executed a power of attorney to and in favor of Md. Irshad and Hashir Barkat as his true and lawful attorneys.
- 5. That after being executed as true and lawful attorneys Sri Nobin Pradhan delegated us with power to lookafter, manage and supervise the entire land. Further we have also been delegated with power to represent on behalf of Sri Nobin Pradhan before any authority, office, BL & LRO and before any Court as required with time.
- 6. That since then we are looking after the land of Sri Nobin Pradhan as his true and lawful attorneys.
- 7. That such land is in greedy eyes of various land grabbers and mafias of the locality as the have illegal greed to take forcible possession of the land by dispossessing us from the land.
- 8. That the land grabbers today at around 11.30 am namely 1. Vikram Chhetri S/o Naina Singh Chhetri resident of Baikhuntapally, Ward no. 41, P.O. Sevoke Road, P.S. bhaktinagar Dist. Jalpaiguri, 2. Kalin Barman @ Karnal Roy S/o Suren Barman resident of Middle Palash, Debidanga, Champasari, P.O. Champasari, P.S. Pradhan Nagar, Dist- Darjeeling, 3. Roshan Rai S/o Late Jit Bahadur Rai resident of Kholachandfapri, P.O. Baikanthapur, P.S. Bhaktinagar along with their associates and gang tried to encroach and take forcible possession of the land. Immediately we approached to the land as we were informed instantly by local people as our well wishers who are residing near the land.
- 9. After a series of severe protests and risk of life we along with local people restrain them from encroaching the land. That while restraining them from their illegal act they hit us with fist and palm and blow us with punch over chest even when we fell down they stabbed us by kicking us brutally with an intention to kill us, we were somehow being rescued by the local people and when the local people intervened to rescue us the leave the place by threatening us to face dire consequences that may led to any extent even to kill us.

10. That they even forged one deed by virtue of which they have claimed to be the owners of land and trying to alienate and transfer the land to third party by such forged and false deed.

That we beg the concerned authority to take appropriate steps and investigate the matter by taking strict actions against Vikram Chhetri, Kalin Barman @ Karnal Roy, Roshan Rai and their gang. Therefore, I request you to investigate and take necessary steps so that the accused persons are punished.
