In producing herewith the arrested accused person namely Goutam Sarkar (30 yrs) S/O Sri Gopal Sarkar of Sukanta Sarani, Milapally, Ward No. 25, PS- Siliguri, Dist-Darjeeling under arrest along with following seized articles as per seizure list viz:-

1. 05 (five) packets of Colour Glizy incredible Sparklers 10 cm, containing 10 Pcs each, VGS Sparkles, Sivakasi.
2. 04 (Four) Pkts of Sparkles Super Colour containing 05 pcs each , M.T Industries Maheshtala, W.B.
3. 01 (one) Box Coronation colour Pinjote Delux Fire Crackers containing 10 pcs each
4. 04 (four) Pkts of Indira's Red Premium Sparklers,30 CM containing 05 pcs each,
5. 01 (one) pkts of Jawan Ground Chkkar Delux containing 10 pcs each.
6. 04 (four) of Puja Chutput MKD by Puja Traders each pkts containing 10 pcs each,
7. 01(one) Golden Torchs super JOG MUG containing 10 Pcs,
8. 28 (twenty eight) Boxes of Magic Paper Shot containing 30 pcs each,
9. 05 (five) of Puja Chut Put containing 10 pcs each , Manufacturing by M T Indtrustries,
- 10.02 (two) Pkts of Akash Ganga 3 in 1 sparkling containing 10 pcs each.

I, ASI Rabin Lama of Siliguri P.S, SPC do hereby lodge this written complaint against accused person Goutam Sarkar (30) S/O Sri Gopal Sarkar of Sukanta Sarani, Milapally, Ward No. 25, PS- Siliguri, Dist-Darjeeling to that effect that on 27.10.24 at 20.45 hrs I received a secret source information the above noted person was storing and selling huge quantity of illegal Fire Crackers in his shop styled as Gopal Varity Store situated at Sukanta Sarani ,Milanpally, Ward No. 25, under Siliguri, Dist-Darjèeling for his wrongful gain This information was diarised in Siliguri PS G.D.E No.1358 dated 27.10.24 and informed the fact to the I/C Siliguri PS. As per direction of I/C Siliguri PS, myself along with ASI Subir Sen, ASI Debasish Das, C/160 Soumen Sarkar , all of Siliguri PS left for Sukanta Sarani, Milanpally under PS Siliguri to verify the veracity of this information.

ASI. Rabin Lama

This refers to Siliguri PS G.D.E No. 1359 dated 27.10.24. After reaching the place of occurrence we cordoned the place and as per identification by source, raid was conducted in the shop styles as Gopal Varity Store situated at Sukanta Sarani, Milanpally, Ward No. 25, under Siliguri after apprehending the above noted accused person who disclosed his identity as noted above and after searching we found the above noted huge quantities of fire crackers stored in his shop and selling the same to the local people illegally for their wrongly gain. On being asked in presence of available witnesses the above noted accused person failed to produce valid papers or license in support of possessing and selling the above noted huge quantities of fire crackers. On further interrogation, he confessed that he had procured the fire crackers illegally and selling the same in locality for his wrongful gain and the said stored fire crackers are combustible in nature and endanger to human life. According I seized the above noted mentioned firecrackers in presence of witnesses after preparing proper seizure list duly signed by the witness and also acknowledge to the arrested accused person. Then after I arrested him after issuing a Memo of Arrest. The whole seizure was made in between 21.14 hrs and 22.05 hrs. Weight of whole item was approx 04 KG.

I therefore pray before you that a specific case may kindly be initiated against arrested accused Goutam Sarkar (30 yrs) S/O Sri Gopal Sarkar of Sukanta Sarani, Milapally, Ward No. 25, PS- Siliguri, Dist-Darjeeling under proper section of law.
