Darjeeling, would like to inform you that, I have entered into the marriage with Sumit Saha, Son of Late Pranab Kumar Saha of Ranidanga, Saha Para, beside Ranidanga B.S.F. Camp, P.S Bagdogra, Dist. Darjeeling on 27/11/2023 according to the Hindu Rites & Customs at my parents house situated at Dayaram Jote, Naxalbari, Dist. Darjeeling.

I would like to further inform you that, at the time of my marriage my father has given a sum of Rs. 1,00,000/- as cash for the expenses of the reception ceremony alongwith One wooden Box Khat, one wooden dressing table, one double door fridge (Samsung), triple door almirah, alongwith gold ornaments (one Necklace alongwith earrings pair, one Sita Har, One Chick, One Sankha Pola set, Male Ring, female ring, Male chain, silver anklets), bedset, utensils and cloths etc as per the demand of my husband and his mother Smt. Chandana Saha and his elder sisters namely Poli Saha and Pinki Saha.

I would like to further inform you that, on 28/11/2023 my husband brought me in his house situated at Ranidanga and on the same day my mother in law took all of my gold ornaments from me and kept in her custody and they have organized a reception ceremony on 29/11/2023 and since then we have started to live together as husband and wife there.

I would like to further inform you that, after the elapsing of few days of my marriage, my mother in law Smt. Chandana Saha and sister in law namely Poly Saha have started to mental torture upon me without any rhyme or reasons, my mother in law and sister in law told me that if my husband got married elsewhere, then they will get more handsome dowry and gifts as because their son is an employee of central Government Bagdogra P.S (Postamat CRPF as constable). After some time my husband also started to use abusive language upon me and my family members, my husband, mother in law, and sisters in law told that my father is a beggar and my parents did not complete their wish and my mother in law also demanded a four wheeler for my husband from my father but my father was

unable to pay such amount to purchase any four wheeler as because my father is a farmer and for that my husband and mother in law used to beaten me mercilessly.

I would like to further inform you that, at the time of my marriage my husband was posted at Janmu & Kashmir and after elapsing of my 18 days of my marriage my husband joined with his service leaving me in my matrimonial house and at that time my mother in law and both sister in laws started to used to torture upon me by mentally and physically, but being a typical Hindu Indian women I swallow all the pain with a hope that everything will be ok with very short of time. But I was totally wrong, my mother in law and sister in law did not allow me to get outside from my house, even I was not allowed to visit my paternal house but my both sister in laws always came to my matrimonial house and used to torture with their mother upon me. Most of the time I used to sleep as empty stomach, I was not able to use my mcbile phone and also restrained from doing any contact with my family members. Every day morning at about 4.30 am I have to wake up from the bed and used to sweep ali the entire of house and also doing daily work since then, I was treated as a maid servant. It is further mentioned that on one occasion my mother in law alongwith my sister in law Poly Saha tried to kill me by pushing me from the first floor but when I came to understand they leave me hurriedly.

I would like to further inform you that, after sometime I heard from my matrimonial house that a marriage was fixed between my husband and another lady but prior to said marriage said lady suicide by hanging herself but most surprisingly my husband used the finger ring which was gifted by the said family members of said lady, but at the time of marriage this information was not providing to us for their ulterior motive and illegal gain.

I would like to further inform you that, due to continuous torture as made by my husband, mother in law and sister in laws I became fall in sick but my mother in law denied to take any medicines to me, finding no other alternative I somehow contact with my elder sister namely Arpita Paul and elaborate everything, then my eider sister came to my matrimonial house alongwith my father and brother in law but my mother in law did not allow my father and elder sister alongwith her husband to enter into their house and subsequently my father and elder sister take the shelter of police and with the help of this police station I was recovered from my matrimonial house on 01/05/2024 and on the said occasion my mother in law put pressurized upon me to write an acknowledge as "*ami Ananna Paul Naxalbari, Dayaram Jote, Darjeeling, 734429 basinda, Ratan Paul Pratibha Paul meye goto 27 November Ranidanga basinda Sumit Sahar sathe bibaho hoyechilo. Ami swa-ichhay ekhan sasurbari theke chole jachi, er jonno keu dayi noy.*" and they also put pressurized upon my parents to sign on the said paper. At that time my

mental health was not good and due to their continuous pressure I bound to write the aforesaid acknowledgement.

I would like to further inform you that, thereafter I tried to contact with my husband and his family members, but my husband used to abusive filthy languages upon me and my parents and also told me that I did not deserved for their family, thereafter my father contacted with the local panchayat and requested them to settle the dispute but my husband denied to come to any meeting and also threatened me with dire consequence and also told me that if I tried to take any legal steps, they will ruin the life of me and my family members and my husband alongwith his mother further threatened me that they have source with upper hand of political party and no one can do anything upon them.

Sir, I have tried my level best to save my conjugal life but due to the constant inhuman torture by my husband and mother in law and sister in laws my life is became unbearable and I have been take shelter of my parents with their mercy, so therefore I request you to take legal action against my husband Sri Sumit Saha, my mother in law Smt. Chandana Saha and sister in laws Poly Saha and Pinki Saha for the ends of justice.
