Sir,

In producing herewith one accused person namely Subhadeep Das, aged 30 years, s/o- Shankar Das, resident of Khudiram Pally, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following fire crackers under proper seizure list:

(i) Twelve (12) packets of 'Assam Super Elephant' chocolate firecrackers, each packet contains 10 pcs: total- 120 pcs, weighing 1.200 KG.

(ii) Seventy (70) packets of 'Samim's Rhino Power' chocolate firecrackers, each packet contains 10 pcs: total- 700 pcs, weighing 33.250 KG.

(iii) Forty (40) packets of 'Lakhi's Rhino Power' chocolate firecrackers, each packet contains 10 pcs: total- 400 pcs, weighing 20.250 KG.

(iv) One (01) bundle 'Ramlakshman's Cobra Chorsa Crackers' (locally known as 'Lanka Crackers'), each bundle contains 50 packets, each packet contains 14 pcs: total- 700 pcs, weighing 2.120 KG.

(v) Three (03) packets of 'Penta+ Pro' firecrackers, each packet contains 5 pcs: total- 15 pcs, weighing 887 Grams.

(vi) Two (02) packets of 'Dadivel Rolling Stone' firecrackers, each packet contains 01 pcs: total- 02 pcs, weighing 1.385 KG.

(Total weight: 59.092 KG)

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written

complaint against the above mentioned arrested accused person to the effect that on 27.10.24 at 18:15 hrs I

received secret source information that a huge quantity of banned fire crackers is stored at the Dashkarma

shop (styled as Shyam Bhandar) cum house of one suspect namely Subhadeep Das at Station More,

Khudiram Pally and the same has been selling illegally from that shop. Accordingly, I informed the matter

to O/C Bagdogra PS and as per direction of O/C Bagdogra PS I along with ASI Amit Lama, C/1509 Sourav

Roy Sarkar, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/386 Kishor Ranjan Howladar, CV/375 jogesh

Barman & CV/389 Janak Singha left for Station More, Khudiram Pally to verify the veracity of secret

source information. This refers to Bagdogra PS GDE No. 1266 dated 27.10.2024. At around 18:30 hrs we

reached at Station More, Khudiram Pally. On being shown and indication by the source, we held raid at the

Dashkarma shop (styled as Shyam Bhandar) cum house of the suspect. On search, the above mentioned

banned firecrackers were recovered. I asked the owner of that shop cum house to produce any valid license/

document for storing & selling fire crackers. But he could not produce any such document. I informed him

that he has disobeyed the orders of the Hon'ble Supreme Court of India vide Judgment dated

23.10.2018 in W.P(C) No. 728 of 2015 and directives of Hon'ble National Green Tribunal in O.A. No.

249/2020 dated 09.11.2020 and 01.12.2020 duly promulgated in all electronic and print media vide memo

No. 321-3L/WPB-E(VI)/2020 dated 26/10/2021 of West Bengal Pollution Control Board that "... there

shall be a complete ban on the sale and bursting of all kinds of fire crackers, except green crackers in the

State of West Bengal, till further orders in this respect ..." On being asked the shop owner revealed his

identity as noted above and confessed that he has been selling such type of fire crackers illegally for his

wrongful gain. He also stated that he was acquainted with the fact that the sale and purchase of all type of

crackers are banned this year as per order of the Apex Court. There is a reasonable ground that the

accused has been negligently and illegally selling those banned fire crackers without any valid

license or permission endangering the human life and has also violated the Govt. order. Accordingly, I

seized the above mentioned banned fire crackers under proper seizure list and arrested the accused person

after observing all legal formalities telling him the ground of arrest for violating the Govt. order and issued

him Memo of Arrest in this regard. The process of search, seizure & arrest was made in between 18:45 hrs

and 19:15 hrs on 27.10.2024. The entire process of search, seizure is done through audio-video electronic

means using mobile phone and then the same audio-video record is converted to a pen drive using computer

system.

Under the above fact and circumstances, I request you to lodge an F.I.R. against the arrested

accused person namely Subhadeep Das, aged 30 years, s/o- Shankar Das, resident of Khudiram Pally, PS-

Bagdogra, Dist- Darjeeling (not verified) under proper section of law and arrange for its investigation.
