I, SI Tanmay Kundu of New Jalpaiguri PS do hereby producing the arrested accused person namely Bijay Saha (28) S/o Lt. Mohan Saha of Thakur nagar PS New Jalpaiguri Dist. Jalpaiguri along with the following seized Fire crackers under proper seizure list viz;

I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodged a written complaint against the above noted accused person to the effect that on the night 26.10.24 at 00-45 hrs I received a source information that one person was carrying huge quantity of Fire-crackers for the purpose of selling the same to his designated customers at Kashmir Colony without having any license or other valid documents violating the provision of law which may endanger human life. Accordingly I share the



information to you and also duty officer of PS and as per your direction myself alongwith ASI Monaj Majumder , C/1462 Sajan Tamang , VP-13 Jamirul Islam all of NJP PS left for Kashmir Colony to verify the veracity of the information which noted in GD vide NJP PS GDE NO. 1403 dtd 26.10.24.


At 01-05 hrs arrived at Kashmir Colony and on being identified by the source I with the help of my accompanied other officer and force apprehended one person with two Cartoon in hand and some others managed to flee away from the spot. On interrogation the apprehended person disclosed his name and address mentioned above. Thereafter the apprehended person was searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted Firecrackers from his possession which was carrying inside the bags. On demand the apprehended person failed to produce any valid documents/licenses in support of the possession of such quantity of Fire Crackers recovered. There is a reason to believe that the said person was storing and selling firecrackers which are combustible in nature and endanger to human life and property. The Fire crackers were stored without any precautionary and safety measure, Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and also the accused person and videographed. Accordingly, I arrested the above noted accused person and issued memo of arrest on the spot duly signed by him. The seizure & arrest was made in between 01-15 hrs to 01-45 hrs.

Under the above circumstances I pray before you that a specific case may kindly be started against the above accused person namely Bijay Saha (28) S/o Lt. Mohan Saha of Thakur nagar PS New Jalpaiguri Dist. Jalpaiguri under proper section of Law, to arrange for its investigation.
