Sir,

I, Roma Ghosh Banerjee, wife of Abhijeet Banerjee resident of Raja Ram Mohan Roy Road, Hakimpara Siliguri would like to inform you that I was married to Abhijeet Banerjee on 28th July 2019 as per hindu rites and customs and at the time of marriage I was given various gold ornaments such as necklace, chur, bala, earring, finger rings etc. and also furniture like king size wooden bed and almirah etc. That after marriage I was taken to my matrimonial house where I started residing along with husband, my father in law and mother in law. That after marriage I notice that my husband used to drink often and even used to sniff weed that he even used to do forceful sexual intercourse with me against my wishes. That thinking about my mother's health, I didnot report about such tortures to anyone. After three months I was told by my husband to handover all my jewelleries to him as his father required the same, so when I denied to do so, I was physical and mental tortured by my husband. That when I complained to my mother in law and father in law about the same they started saying that "Tomar moto meye ka mara uchit" . That my mother was thereafter called to my matrimonial house by my husband, who was a sugar patient and was insulted stating that what have you taught your child, she knows nothing hearing to such taunts my mother had a sugar fault lost her senses over there. That after that my mother suggested to give my husband all my jewelleries and accordingly I had handed over the jewelleries to my husband.

That in the year 2019 my husband had TB and my father in law and mother in law started accusing me that if something happens to their son then they will not leave me. They also started blaming me that it was because of me that their son is not well and when I said that he was sniffing weed that should be stopped, my husband, mother in law and father in law physically tortured me stating that I am a "apaya" and have brought bad luck in their family. That i was not given proper food and was told that i have no control over my eating habit. That I used to talk over phone with my mother as my mother was not well and this was also not liked by my mother in law as well as my husband to which my husband started physically torturing me not to have any conversation with my mother as the same was not liked by his family members and when I tried to make him understand he became furious and even beat me with his belt, made me kneel down for hours at night for not listening to his instructions. That when my father came to meet me in my matrimonial house, my father in law and mother in law started complaining that my mother controls me like a remote control and my mother's instruction won't run in this house.

That my husband was running a hot box restaurant business, in the year 2021, when I visited his place of business he became furious as to why i had come to his business premises and abused me in front of his staffs and told me to get out. That whenever I used to cook in the kitchen my mother in law and father in law didnot eat my cooked foods stating that I must have done black magic. That on 18th February 2021 my mother died and I was very depressed , but my husband physical and mental tortures me by saying as to why I was spending time in my parental house, at that time Anima Masi was the house servant of the house and they used to tortures on me infront of her. After some days the house servant was also left and i was made to do all the household works.

That my sister in law on and off after my marriage used to come to my matrimonial house and whenever i did something in the kitchen, she used to taunt me by saying that "bhalo paribar peyecho bola paar peye jacho anno chele hola kobe berk kore ditto". That my sister in law always had an air of being highly educated and used to taught by saying that "bairer kaj korte paro na barir kaj toh bhalo kore shekha uচিত chilo." When i protested to her such saying, she and my mother in law started provoking my husband by saying that how dare i answer back, my husband didnot beat me enough or i would have learnt the listen. After which my husband used to take to the room and used to physically abuse me, spit on me and even raped me. That seeing the ill health of my mother i have not revealed these tortures to anyone. That my sister in law used to say to me that my father in law tells me to get out of matrimonial house, my husband tells me to get out of the matrimonial house even my mother in law tells me to get out of the matrimonial house still like shameless I stay in this house. Thereafter she tells me that whenever she sees me she wants to give a tight slap to me. That my sister in law also used to instigate my husband to torture me and also used to say him to drive me out of the matrimonial house and he will get far better women than me. That in the month of September, 2023 my sister in law went to Canada and even after going to Canada, she didnot stop her instigation for over phone she used to instigate her mother and brother to torture me.

That from the year 2023 I was stopped from entering the kitchen and was not given any food to eat. My husband, mother in law and father in law told me to leave my matrimonial house as my father had not given any dowry at the time of marriage, without paying an amount of Rs 500000/- (Rupees Five Lakhs Only) I will not be able to stay in their house. That I reported the same to my father, my father came to talk to my in-laws but was again insulted and told to take me to my parental house but my father seeked for some time. That for days I was not given food, my husband used to eat with his parents and I used to starve for foods. That my father started sending food from my parental house which was also not liked my by husband and in-laws sometimes they used to throw the food. My mother in law started saying to me that she as well as my sister in law will give marriage to her son in a rich family and she is already looking for the same. That on 22nd October 2024, my husband told me to leave my matrimonial house as my father has failed to live up to his promise, when i refused to leave my matrimonial house he started hitting me with kicks and blows, even my mother in law joined him and started pulling my hair, my father in law also supported them by saying that I have no place in their house, and drove me out of my matrimonial house. That I had thereafter taken shelter in my parental house at Hakimpura Siliguri. I was mentally very depressed and so there has been delay in lodging the FIR.

I therefore request you to take action against my father in law Amal Banerjee, Mother in Law Deepa Banerjee, Sister In law Tanaya Banerjee Sen and my husband Abhijeet Banerjee. All of Syed Mustaba Ali Road, Hakimpura 1st
