Subject: Urgent Complaint Against Vishal Chauhan for Repeated Violation of Court Orders, Cyber Harassment, Physical Assault, Stalking, and Unauthorized Contact.

Dear Sir/Madam,

I, Divya Gupta, am submitting a formal complaint against Vishal Chauhan for ongoing cyber harassment, physical assault, stalking, unauthorized contact, and repeated violations of court orders. Despite prior arrests and a court mandate barring him from contacting me, Vishal has continued to harass me, violating the court's orders and disregarding the law.

On **25/10/2024**, Vishal began sending threatening messages to my family members, warning them that he would soon circulate additional private videos of mine. Later that day, he proceeded to distribute these videos to my family and relatives, in which he was physically assaulting me, causing extreme emotional distress and further violating my privacy and the court's orders. Furthermore, he escalated the harassment by using a fake Facebook profile on **26/10/2024** to send these videos to my friends. The harassment has continued today, **27/10/2024**, with Vishal sending messages from various numbers, ignoring all legal restrictions and boundaries, making it impossible for me to remain silent.

Although Cyber PS previously seized Vishal's phone, he had already copied my private videos and contact details onto his mother, Beena Chauhan's, phone (**9131955761**) (as I stated in my previous FIR dated 17/06/2024), and shared these files with others. Since then, Vishal has contacted me using multiple numbers in violation of court orders, including those I have already listed in my earlier complaints. He has also recently contacted me and circulated videos using the following numbers: **9625972290** and **7830331577**.

Vishal's ongoing threats, coupled with his past stalking, have caused constant fear for my safety, as documented in Pradhan Nagar Case No. 461/2024, filed on 19 July 2024. Due to his continuous intimidation, I am unable to work regularly, fearing he may follow or harm me.

Enclosed with this complaint are records of previous FIRs, complaints, and video evidence of repeated harassment, including:

- Cyber Crime PS No. **42/2024**, filed on 26 March 2024
- Pradhan Nagar Case No. **461/2024**, filed on 19 July 2024

I am prepared to provide any additional information or proof necessary for a thorough investigation and resolution of this matter. I respectfully urge immediate action to ensure my safety and protect my privacy from further violations.
