LASI Bhanu Pradhan of NBMC OP under Matigara PS, Siliguri Police Commissionerate do here by lodged the complaint to the effect that on today i.e. 28.10.2024 at evening during my evening patrolling duty, receive source information that one Pintu Majumder had been storing and selling the illegal fire crackers at his house cum shop at Kawakhali under PMC OP, Matigara PS. Accordingly I informed the information to O/C NBMC OP under Matigara PS and as per his direction vide NBMC OP GDE no-915, Dated: 28.10.2024 myself along with force conducted raid against selling, storing of illegal fire crackers in the house cum shop of Pintu Majumder of Kawakhali as there was secret source information that he had been storing and selling the fire crackers of 'eyond permissible sound limit illegally to the customers. During raid apprehended one person who on being asked identified himself as Pintu Majumder (25yrs), S/O- Mahananda Majumder of Kawakhali, PO- Sushrutanagar, PS-Matigara, Dist - Darjeeling and found him possessing above noted seized fire crackers kept concealed in his house cum shop.

On being asked Pintu Majumder admitted his guilt of purchasing, storing and selling of fire crackers at his house cum Shop without licence. He also could not produce any documents in respect of huge amount of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at this shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly med by the witnesses. Accordingly, I arrested the above noted person u/s 35 BNSS and acknowledge to the accused person. The seizure was made in between 20.26 hrs to 20.45 hrs.

Hence, I pray before you that a specific case may kindly be started against the above noted person namely Pintu Majumder (25yrs), S/O- Mahananda Majumder of Kawakhali, PO- Sushrutanagar, PS- Matigara, Dist - Darjeeling under proper section of law and arrange for its investigation.
