Sir,

With humble submission, I would like to bring to your kind notice that I Bikram Singh, S/o Sri Titak Singh, resident of Dagapur, Bandigote, was travelling to Darjeeling from Siliguri, today. I must highlight that I own a Wagonr vehicle having registration no 'WB 73 E 6430' which I use as a commercial passenger vehicle and earn my livelihood from it.

My vehicle was hired by Dr. Arjun Chowdhury, State Government Advocate at Calcutta High Court, for some court appearance at Darjeeling district court. I picked him up from Shimla today at around 8:00 AM and just when we crossed Balsara Hotel at Matigara, few persons stopped our car and started asking for money. I told them to go away and allow us to proceed, but two of them started beating me by fist and punches through the window. Even before I could respond, they dragged me out of the car and stalled furiously beating me by kicks and blows and even torn my clothes.

At that time, Dr. Chowdhury, came out of the car to stop them. Few local persons also rushed to rescue me. When Dr. Chowdhury took out his mobile phone to call the police they fled away from the spot. I have received injuries in my eye, chest and shoulder.

After some enquiry from the local people and came to know that one of the person who assaulted me was Bittu, s/o Dinesh, resident of Baniakhuli Lalpoot and they all were members of local club namely 'Tarun Sporting Club' and they were extorting money from passer-bys for organising Kali Puja.

However, I came to know that these people are extorting money from everyone passing through that road for their own personal gains and those denying to their demands becomes victim of their assault.

I pray before your good office to immediately arrest everyone involved in the racket of extortion and assault of myself as well as other innocent people.
