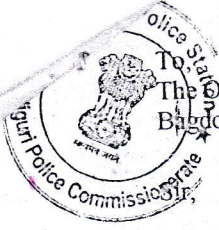

In producing herewith one accused person namely Ranan Kundu, aged 31 years, s/o- Ramen Kundu, resident of Lokenath Nagar, Bhujipani, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following fire crackers under proper seizure list:

- (i) One hundred and twenty (120) packets of 'Samim's Rhino Power' chocolate firecrackers, each packet contains 10 pcs: total- 1200 pcs.
(ii) Three (03) bundles 'JMD King Cobra Extra Power Electric Crackers' (locally known as 'Lanka Crackers'), each bundle contains 50 packets, each packet contains 28 pcs: total- (3x50x28) = 4200 pcs.

I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the above mentioned arrested accused person to the effect that on 29.10.24 at 17:45 hrs I received secret source information that a huge quantity of banned fire crackers is stored at the Dashkarma shop of one suspect namely Ranan Kundu at Lokenath Nagar, Bhujipani under Bagdogra PS jurisdiction and the same has been selling illegally from that shop. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS I along with ASI Amit Lama, ASI Munna Ahmed, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/386 Kishor Ranjan Howladar, CV/375 Jogesh Barman & CV/389 Janak Singha left for Lokenath Nagar, Bhujipani to verify the veracity of secret source information. This refers to Bagdogra PS GDE No. 1353 dated 29.10.2024. At around 18:00 hrs we reached at Lokenath Nagar, Bhujipani. On being shown and indication by the source, we held raid at the Dashkarma shop of the suspect. On search, the above mentioned banned firecrackers were recovered. I asked the owner of that shop to produce any valid license/ document for storing & selling fire crackers. But he could not produce any such document. I informed him that he has disobeyed the orders of the Hon'ble Supreme Court of India vide Judgment dated 23.10.2018 in W.P(C) No. 728 of 2015 and directives of Hon'ble National Green Tribunal in O.A. No. 249/2020 dated 09.11.2020 and 01.12.2020 duly promulgated in all electronic and print media vide memo No. 321-3L/WPB-E(VI)/2020 dated 26/10/2021 of West Bengal Pollution Control Board that "... there shall be a complete ban on the sale and bursting of all kinds of fire crackers, except green crackers in the State of West Bengal, till further orders in this respect ..." On being asked the shop owner revealed his identity as noted above and confessed that he has been selling such type of fire crackers illegally for his wrongful gain. He also stated that he was acquainted with the fact that the sale and purchase of all type of fire crackers are banned this year as per order of the Apex Court. There is a reasonable ground that the alleged accused has been negligently and illegally selling those banned fire crackers without any valid license or permission endangering the human life and has also violated the Govt. order. Accordingly, I seized the above mentioned banned fire crackers under proper seizure list and arrested the accused person after observing all legal formalities telling him the ground of arrest for violating the Govt. order and issued him Memo of Arrest in this regard. The process of search, seizure & arrest was made in between 18:17 hrs and 19:06 hrs on 29.10.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Under the above fact and circumstances, I request you to lodge an F.I.R. against the arrested accused person namely Ranan Kundu, aged 31 years, s/o- Ramen Kundu, resident of Lokenath Nagar, Bhujipani, PS- Bagdogra, Dist- Darjeeling (not verified) under proper section of law and arrange for its investigation.
