**Complaint against for causing harassment / Blackmailing/
threatening and also denuding me in society.**

Respected Sir,

I, Smt. Koyel Mandal D/o Niranjan Mandal, resident of Siliguri Champasari, Pokaijoth, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, do hereby led to you the following incidents which being constantly had done upon me by the fellows namely as Sri Piyush Kumar Sharma, S/o Arbind Kumar Sharma, R/o Purnia, Tatmatali, nearby Newalal Chak, Dist. Purnia, Bihar and Sri Sajal Das S/o Late Sahadeb Das, Champasari, Pokaijoth, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, who are known to me, amongst them Sajal Das is my own Maternal Brother and the other fellow Piyush Kumar Sharma with whom I came in contact first time at Purnia on the day of 26th December, 2020 in an event show where I participated as a dancer. Then he identified himself as Medical Representative. Since thereafter he used to contact me by his cell phone of and on as a mark of friendship. During this time Piyush became acquainted with my maternal brother Sajal through me. Gradually since then Sajal became very close to Piyush, who used to go since then so many times at Bihar to meet with him, in turn to that Piyush also used to come at our place at Siliguri in order to meet with Sajal. At Siliguri Piyush whenever used to come from Bihar, he used to stay at different hotels, then he used to come to our premises also. Gradually our relationship became turn in affairs wherein Sajal have a key role. Then on his (Piyush) assurance to marry me I went with him in a rented residence of him at Champasari, Pokaijoth. Where we stayed for certain

times since onward from February of this Year to upto the end of May of this current year 2024. During this period in the mid of May, 2024 I came to learn that Piyush got his family at Bihar, who fully misrepresented me as a divorcee and as he betrayed me and ruined my life and as such I got severe and cut off all connections with him. Having so Piyush became so furious to me, he then with the help of Sajal started to cause harass me in various ways. During our staying together Piyush have got number of my photographs, which all are my private photos, same never be fit to expose in the society. He since our differences threatens me to post the same in the social medias and also in the porn sites, so that I may not to come in society again. He used to threatens me using different phones in different times. Besides this he also constantly then threatens me for committing suicide so that I can be punished by law as abettor abetting for his suicide. Constantly then he started to threaten me in my mobile to take my life using the contract killers, who are available to him at Bihar. Not only that he also started spreading scandals against me to so many ones with whom I have acquaintances. In that processes he started to denude me in society and to finish my carrier and tarnish my images in my professional field. For his such repeated tortures I became mentally completely broke down and became compelled to confine me in my house leaving my professions and livelihood.

Piyush also started to threatens me that he will falsely implicates me in the Drugs paddling cases and in that process in the meantime 5 times he succeeded to convince police agencies that I have got nexus with the paddlers, accordingly police invaded five times to my house and made open search there even in a odd hour of night without having any search warrant, in a occasion on last 17th October. Though police could not find any clue against me in any occasions. For such actions I became exposed to my society as a Drugs paddlers under the mask of my dancing profession. In all occasions in my queries police disclosed me they got a credible information from Piyush Kumar Sharma and Sajal Das

about my nexus with the drugs paddlers. Not only that even the aforesaid fellows were being succeeded in convincing The Narcotics Control Bureau Siliguri Zonal Units in this regard and being so NCB on 17/10/2024 searched my premises and on being found nothing they issued a Nil sizure list to me as a mark of evidence. On my asking NCB reported me both above fellows of Piyush and Sajal led this information to them for which they had search my house. Such a nefarious concocted series of actions of Piyush and Sajal my life became hailed and I lost my credibilities and reputations which substantially cause harm my professions and identities.



In the circumstances I seeks my protections from your end.


So therefore I am requesting you do the needful immediately for my protections and to take the proper actions as per law against the said culprits Piyush Kumar Sharma and Sajal Das.
