in the Valmiki Vidyapeeth Kali Raja purpose,  
When he was returning the accused person  
Mr. Ranjan Naha, his son and their friends  
physically tortured ~~the~~ tremendously my  
husband. There was an attempt to murder  
to kill my husband if not rescued in time.  
He is brutally injured with tears in head &  
rib cages. My son & his cousin brother when  
tried to rescue him. he, they were  
brutally beaten.

The accused people have been violently beating and disturbing my husband and my family for many days.

They tried murdering but escaped merely. I called '100' and the reporting police when visited the violenters escaped till them.

I want some justice, it has become extremely difficult for me, my son & my family to live.
