Subject: FIR against Mr. Vivek Barman for abuse, threats, and physical assault.

Respected Sir,

I, Sankar Roy, son of Mr. ~~Khoka~~ Khoka Roy, resident of Bhupendra Nagar, Ward No. 42, am filing this report regarding a serious incident involving Mr. Vivek Barman, also a resident of Bhupendra Nagar, Ward No. 42.

On the night of 01.11.2024 at approximately 12:00 AM, Mr. Vivek Barman was verbally abusing someone in the presence of my brother, Jyotish Roy. When he intervened and questioned whom he was abusing, he reacted aggressively. He began hurling abusive language at me and issued threats. Further, he used offensive language, pointing towards my parents in an extremely disrespectful manner.

As he attempted to stop him from continuing this behavior, he suddenly attacked him, resulting in a severe head injury for which he required 4 stitches (Hospital Slip attached with the FIR)

The unprovoked attack, coupled with threats and abusive language, has caused him considerable physical and emotional distress. Given the seriousness of these actions, I request that immediate and strict legal action be taken against Mr. Vivek Barman to ensure my brother safety and deter any such future incidents.
