I, **SRI RANJAN SAHA**, Son of Late Nirmal Kumar Saha, presently residing at Vidyasagar Pally, Ward No.- 7, Near Hari Mandir, P.O & P.S. - Siliguri, Dist.- Darjeeling beg to inform you that on 31-10-2024 at about 8.00 p.m. when I my other family members are busy in celebrating kali puja at my house at above mentioned address at that time one of my neighbor namely **BAPI GHOSH**, Son of Late Thakur Das Ghosh resident of same locality enter into my house and when I and my family members are busy in puja at that moment the above name person namely Bapi Ghosh taking chance taken my minor daughter namely **MISS. MEGHNA SAHA** age about 9 Years in a lonely place of my house when she is busy in playing and he started to touches her body with intention to make sexual harrashment and instigate her for the purpose for sexual favour and to fulfill his sexual flavour he i.e. Bapi Ghosh kiss my said minor daughter on her cheek forcefully with intention to full fill his ugly motive and due his forcefull kiss my said minor daughter got black spot injury on her face and thereafter due to many number of persons are present in my house the above name person not success in his ugly motive and leave my daughter at my house and left my house and after few hours my wife namely Smt. Rita Saha noticed that some black spot on her cheek look like someone cut her cheek with teeth and when my wife enquiry about such mark my said daughter not give any clear answer about such injury due to fear and I and my wife busy in the puja and after completion of puja on **02-11-2024 at about 7.00 p.m.** the above named person again came to my house and started to instigate my daughter by giving illegal posture and my said daughter become frightened to see the above named person then after deep enquiry my said daughter narrated the aforesaid fact to my wife about the ugly behavior of above named person and the fact narrated to me then I inform this fact to the para people and also my ward and then I came to know that the above name person is are very desparate and had intention person and to fulfill his a ugly intention he make such illegal act with my said daughter.

So I therefore prayed that please take necessary steps against the above named name persons to arrest them and protect my daughter from his bad intention.
