resting in my room, then suddenly, the above mentioned
person namely Milan knocked at my door along with
his wife, when I open the door, I was with my wife
they started abusing me and my wife with vulgar
comment and using filthy language, and when
I tried to stop being a handicapped, I lost my right
leg several years ago, by seeking that advantage the
above mentioned name Milan @ minal hit me with
an Iron Rod in the left side of my head. after which
I became unconscious and fell on the floor. I am
still in pain and having a swell on my head
which lead to dizziness frequently.

Sir, I would ask to seek your attention to the above mentioned facts and like to request you to look in to the matter as soon as possible as the matter is very serious in nature and for the protection of my family.

Sir, I have submitted the medical report and along with my handdscrp certificate in which it is mentioned that I am 70% disability in my right leg.


