Dareeling would like to inform you that yesterday i.e. on 02/11/24 at about 07.00 p.m. my minor daughter namely Nandini Paswan, aged about 16 years told me that she wants to see Kali Puja Pandel and after taking permission from me my minor daughter went to near Baghajatin Park and after expired of couple of hours when my above named minor daughter not returned at my home at that time me and my whole family members tried to trace her but we failed and ultimately today i.e. on 03/11/24 it came to my knowledge that one person namely Sri Badal Paswan, S/o. Not Known, R/o. Shanti Nagar, JabraVita Housing, P.S. NJP, Dist. Darjeeling ( Ph. No. 8927781422 ) forcefully kidnaped my minor daughter and confined her so, there is a every possibility that the above noted person can sell out my above noted daughter at any time so, no other alternative way today I lodged this complaint before you against the above noted person.

It is therefore I request you please take necessary legal action against him and also recovered my above noted daughter from his hands as early as possible.
