This is to bring your kind information to the fact that I, Pooja Sahani No. Rajkumar Sahani residing at Maharaj Colony, Santokh Nagar, Ward no-5, Dist. Darjeeling, Siliguri. I want to state that my mother and father is selling "Chulla" on Burdawan Road near Reliance Mall. My father and mother was selling the Chulla at the rate of Rs. 150 - Rs. 200. There was another man Sukindar Sahani and Radha Sahani also selling the Chulla but my father told the customer that the rate of Chulla is 150-200, then both this people started shouting that he is selling in Rs. 150 for attracting the customer.

Over this issue today on 03/11/24 at about 06:00 P.M to 06:30 P.M at Burdawan Road near Reliance Mall and they started biting with teeth to my parents badly and pushed them on road, they felt bitter that they used iron rod and bamboo lathi and started biting my parents and when I want to save my parents they have bitten me also. They have bitten my parents as my mother became senseless, Radha Sahani pulled out my mother's gold earrings; as she became senseless, then I admitted my parents is Siliguri District Hospital and they are under treatment.
