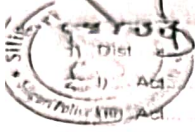

Sub : F.I.R. relating to an accident with a ToTo by a Tata Ace Pick
Van bearing Registration No.WB-73/G-0815.

Sir,

I, PRITAM DAS, son of Late Manotosh Das, resident of Deshbandhupara, Near Indoor Stadium, Post Office-Siliguri Town, Police Station-Siliguri, District-Darjeeling, would like to inform you that on 03.11.2024 at about 10.00 P.M. while we were accompanying one emersion procession of Godess Kali Maa, towards Lal Mohan Moulik Emersion Ghat, my sons, Master Sayak Das, aged about 12 years, Master Arya Das, aged about 3 years and one Miss Shristi Tapadar, aged about 9 years were going in a ToTo and when we were crossing Hill Cart Road, Opposite Hotel Niladri Palace, one Tata Ace Pick Up Van bearing registration No.WB-73/G-0815 at the time of overtaking our procession from the back left side with very rash and negligent driving, suddenly, said Tata Ace Pick up van dashed my wife, Smt. Madhumita Das, aged about 30 years, from her back side, who was standing there in our procession line and thereafter dashed our said ToTo very recklessly, result of which, said ToTo had volte-face in the road and being uncontrolled said Pick-up Van was stranded behind our ToTo. As a result of said accident, my wife, Smt. Madhumita Das has sustained severe injury in her spine and in heap-joint and now admitted in Sunrise Nursing Home in serious condition, my two sons were also sustained injury, but, they were released from Siliguri District Hospital after giving preliminary medical attention. Miss Shristi Tapadar has been admitted in Maharaja Agrasen Hospital in a serious condition having leg fractured injury, after being referred from Siliguri District Hospital. At the time of incidence police came to the place of occurrence and all the injured persons including abovenamed persons were taken to Siliguri District Hospital.


