[Sub:- FIR against the driver of Eco Sport (white colour) and 20/25 others)

Sir, I, Rahul Garg, son of Subash Ch. Garg resident of Ward No. 09 of Siliguri Municipal Corporation, Post Office and Police Station-Siliguri, District-Darjeeling, would like to lodge this written complaint against the driver of Eco Sports (white colour) and his associates for theft after preparation made for causing death. I along with my friend Mohsin Raza son of Rashid Raza resident of Khalpara, Siliguri had been to "Sagar Restaurant" to have dinner and at about 10:00 P.M, while we were returning home the accused (3 numbers i.e 2 male and 1 female) seated in Eco Sports (white colour) started to follow/chase us, which raise suspicions in our mind. We tried to escape from the clutch of the accused but the accused who were in car as mentioned above managed to stop/obstructed way of our vehicle near Payal Cinema Hall under Bhaktinagar Police Station, District-Jalpaiguri and as soon as we stop our car, the accused who were seated in the car came out from the car and all of a sudden attacked and snatch gold chain from my neck, weighing 30 grms i.e half of said chain, as on protest it breaks. In a blink of an eye the accused called and 20/25 other associates of accused gather thereat and started to beat us mercilessly with iron rod and other sharp weapons which they were carrying with them and in furtherance of common intention they tried to take searched our pocket for cash but failed as no cash was left with us at that point of time. When the local police from traffic point rushed towards the place of occurrence, the accused fled away with half portion of my gold chain. I can identify the accused and car which they used, if brought before me. I was admitted to Siliguri Civil Hospital for treatment and thereafter shifted to "Agogya Niketan Nursing Home" situated at S.P Murkherjee Road, Khalpara. One of the accused is known as "Pappu" which we understand from conversation in between the accused person(s) on phone call.

It is my earnest request to you please do the needful and obliged me by taking necessary legal action against the accused persons and also recover half portion of my gold chain.
