Sir/Madam,

This is to bring to your kind attention that around 0.400 KM ACSR 30SQMM (and 0.100KM of ACSR 3phase, 4wire LT network) have been found to be theft by some unknown miscreants from the live LT network situated at Bholanathpara (near Vaas Utensils Factory).

Such notorious act doesn't only cause a financial loss to the tune of Rs. 20,000.00 (approx.) to WBSEDCL but also poses threat to the safety of the WBSEDCL's network. However, WBSEDCL didn't receive any 'No Power' complain from that area which could have helped us to detect it earlier. However, it may be worthy to mention that such kind of activities involving theft of WBSEDCL property had previously been reported twice at its nearby location & your good office was duly informed about those matters too vide Bhaktinagar PS FIR No.: 798/2024 dated: 03.09.2024 & 835/2024 dated: 13.09.2024.

Hence, your good office is requested to take cognizance of the matter & consider this complain as FIR to take necessary action u/s 136 of the Electricity Act, 2003 (read with amendments) & other relevant laws of the land for the theft of WBSEDCL's property.
