Sir.

With due regard and humble submission I Sushma Tamang daughter of D.K. Tamang, resident of Post office Road, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri do hereby submit the following for your kind perusal and necessary legal action :-

1. That on 01/11/2024 about 12:45 when my younger brother namely Pankaj Tamang and his friend namely Tilak Tamang, both were returning back to their house from the Farm House situated at Singhi Jhora Busty, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri and when they both reached at near Thutta Busty, suddenly the above named Culprits and their Associates started to abuse my brother and his friend in filthy language and when my brother and his friend protested then all of sudden became furious and started to Assault my brother and his friend mercilessly and they all beat my brother by punching continuous (Blows) on his face and hit him by bamboo stick all over his body and broke the tooth & smashed ribs of my brother and they also snatched all of his belongings i.e his newly purchased watch, Rs. 12,000/- from his pocket and a Golden Chain & Finger Ring for their ill motive and until and unless when my brother became serious /senseless Chanda Gurung along with other lady above named threw drain dirty wastage upon my brother and beat him with stone and all the above named culprits then threw my brother on road side and ran away. And the intention of the above named culprits was to kill my said brother for their ill motive and to hide their un-lawful activities which they commit upon my brother.
2. That one person of Salugara brought my brother to house in a very bad condition and his face was full of blood and his tooth were broken and he was crying with pain on his body & ribs & blood was coming out from his mouth and I and my old aged mother took my brother Pankaj to the Siliguri Sadar Hospital for treatment on 01/11/24 in a very bad condition.
3. That when I and my mother went to the Police to File F.I.R against the above named culprits the Duty Officer asked the name of the culprit as I was not aware of the name so the Police told to collect the name of the said Culprits and refused to take the FIR on 01/11/2024.
4. That my said brother is in a serious condition and he is under treatment of 158 Base Hospital Bengdubi as his condition is very serious. And the Medical report will speak all the truth condition of my brother. (Xerox Copy enclosed for perusal)
5. That today I and my mother went to the spot and on search came to know the names of the said Culprits who assaulted my younger brother mercilessly and snatched all of his belongings for their ill motive. And the Character of the above named Culprits is not good and they are involve in many criminal activities in the area.
6. That from sources I have come to know that one of the culprit is the owner of a Truck and a Omani and is a Driver by profession.
7. That the above named Culprits are very dangerous and can do anything in order to save themselves from their said illegal act and activities which they committed upon my brother.

Under the above facts and circumstances you are requested to please take legal steps / action against above named Culprits and their associates who mercilessly used criminal force and beat my brother and his friend and snatched all the belonging of my brother forcefully in a illegal manner and broke the tooth & fractured ribs of my brother by using Criminal force / beating him in a very danger manner for their ill motive and if they are not punished then they will repeat their illegal act and activities / Criminal acts to others.
